TENNESSEE VALLEY AUTHORITY WARRANTY DEED

STATE OF NORTH CAROLINA—SWAIN COUNTY

(DOCUMENTARY STAMPS ATTACHED \$7.70)

THIS DEED, Made this 28 day of January, 1944, by and between

HENRY B. ANTHONY and wife, MARTHA ANTHONY,

of the County of Swain and State of North Carolina, as parties of the first part, and the UNITED STATES OF AMERICA as party of the second part: WITNESSETH, That the said parties of the first part, in consideration of the sum of SIX THOUSAND SIX HUNDRED SEVENTY-SEVEN AND 66/100 - - - - - Dollars (\$ 6,677.66) to them paid by the party of the second part, the receipt of which is hereby acknowledged, have bargained and sold, and by these presents do grant, bargain, sell and convey unto the UNITED STATES OF AMERICA, its successors and assigns, a certain tract or parcel of land, situate, lying and being in Swain County, State of North Carolina, and more particularly described as follows, to-wit:

A tract of land lying in Forneys Creek Township of Swain County, State of North Carolina, on the right side of the Tuckasegee River, approximately 2 miles northwest of the mouth of Forney Creek, and more particularly described as follows:

Beginning at a stake in a fence line and at the top of a ridge, a corner of the lands of the Bryson City Bank, the U. S. Department of Interior (Great Smoky Mountains National Park), and Caro Lee Cole, and the most northerly point of the tract herein described; thence with Caro Lee Cole's line and the fence line S. 4° 00' W., 2150 feet to a railroad iron; thence with a fence line for the last approximate 240 feet S. 86° 00' E., 980 feet to a stake, a corner of the lands of Caro Lee Cole, and E. M. Anthony; thence leaving the fence line and with E. M. Anthony's line S. 7° 00' W., 320 feet to a rifle barrel in a fence line, a corner of the lands of E. M. Anthony, and the A. J. Montieth Heirs; thence with the A. J. Montieth Heirs' line and with the fence line for the first approximate 220 feet S. 8° 00' W., 2600 feet, crossing Gunter Branch at approximately 1800 feet, to an iron pin; thence N. 83° 00' W., 1605 feet to a point; thence N. 85° 00' W., 1390 feet to a bed rail at the top of a ridge, a corner of the lands of the A. J. Monteith Heirs, and R. E. L. Kirkland; thence with R. E. L. Kirkland's, and the Bryson City Bank's line and the top of the ridge as it meanders approximately along the following bearings and distances: N. 8° 30' W., 580 feet, N. 30° 00' E., 345 feet, N. 50° 30' E., 765 feet, N. 34° 30' E., 450 feet, N. 21° 30' E., 850 feet, N. 29° 00' E., 2630 feet to the point of beginning, and containing 197. acres, more or less.

It is understood and agreed that the bearings given in the above description are based on the North Carolina State Coordinate System, Lambert Projection, as established by the U. S. Coast and Geodetic Survey. The central meridian for this coordinate system is located at Longitude 79° 00' W.

The above described tract of land was acquired by H. B. Anthony, one of the first parties hereto, by intestate succession as an heir at law of W. M. Anthony, deceased, and by the following deeds of record in the office of the Register of Deeds for Swain County, North Carolina: (a) Deed from A. T. Dorsey et ux, dated April 12, 1919, recorded in Book 47, page 146; (b) Deed from E. C. Monteith et al, dated March 13, 1908, recorded in Book 35, page 359; (c) Deed from W. W. Anthony et ux, dated January 5, 1912, recorded in Book 41, page 19; and (d) Deed from M. A. Anthony et ux, dated February 13, 1918, recorded in Book 47, page 145.

The Henry B. Anthony who is named as one of the first parties in this deed is one and the same person as the H. B. Anthony who was named as grantee in the deeds recorded in Book 47, page 146; Book 35, page 359; Book 41, page 19; and Book 47, page 145, in the office of the Register of Deeds for Swain County, North Carolina.

TO HAVE AND TO HOLD the aforesaid tract or parcel of land and all privileges and appurtenances thereto belonging, to the UNITED STATES OF AMERICA, its successors and assigns, to its own use and behoof forever. And the said parties of the first part, for them selves, their heirs, successors, administrators and assigns, covenant with the said party of the second part, its successors and assigns that they are seized of said land and premises in fee, and have right to convey the same in fee simple; that the same are free and clear from all encumbrances and that they will warrant and defend the title to same against the lawful claims of all persons whomsoever.
