This Deed, Made this 10th day of April, 1944, by and between Louis E. Fischer and wife, Mae Fischer, of the County of Cook and State of Illinois, as parties of the first part, and the United States of America as party of the second part:

Witnesseth, that the said parties of the first part, in consideration of the sum of Twelve thousand seven and 75/100 Dollars (\$12,007.75) to them paid by the party of the second part, the receipt of which is hereby acknowledged, have bargained and sold, and by these presents do grant, bargain, sell and convey unto the United States of America, its successors and assigns, a certain tract or parcel of land, situate, lying and being in Swain County, State of North Carolina, and more particularly described as follows, to-wit:

TRACT NO. FR-1041

A tract of land lying in Forneys Creek Township of Swain County, State of North Carolina, on the right side of the Little Tennessee River, approximately 2-1/4 miles northwest of Bushnell, and more particularly described as follows:

BEGINNING at a stone in the center line of a road on the west boundary line of the tract herein described, a corner of the lands of Mrs. Laura Stephenson, and Oscar Kirkland; thence with Oscar Kirkland's line and the center line of the road as it meanders approximately along the following bearings and distances: N. 34° 30' E., 845 feet; N. 52° 30' E., 120 feet; N. 8° 00' E., 360 feet; N. 10° 30' E., 555 feet to a point in the center line of Big Branch; thence with the center line of the branch as it meanders upstream approximately 230 feet to a point, a corner of the land of Oscar Kirkland, the land in dispute between Arnold Kirkland and Oscar Kirkland, and the land in dispute between Arnold Kirkland, and the Bryson City Bank; thence, leaving the branch and with the line claimed by Arnold Kirkland as his south boundary line, S. 32° 15' E., 200 feet to a 15 inch hickory tree; thence S. 71° 00' E., 490 feet to a 3 inch black gum tree; thence N. 41° 30' E., 1220 feet to a point, a corner of the land claimed by Arnold Kirkland, and the land of the Bryson City Bank (An adjoining tract); thence with the Bank's line S. 82° 30' E., 450 feet to a point; thence S. 7° 30' W., 2240 feet to a point at the top of a ridge, a corner of the lands of the Bryson City Bank (an adjoining tract); and H. B. Anthony; thence with H. B. Anthony's line and the top of the ridge as it meanders approximately along the following bearings and distances: S. 34° 30' W., 450 feet; S. 50° 30' W., 765 feet to a point, a corner of the lands of H. B. Anthony, and R. E. L. Kirkland; thence with R. E. L. Kirkland's, and Pearley Kirkland's line N. 83° 00' W., 1790 feet, crossing the top of a ridge at 1080 feet, to a stake, a corner of the lands of Pearley

Kirkland, and John W. Kirkland et ux; thence with John W. Kirkland's line N. 13° 30' E., 300 feet to a stone in the center line of a road, a corner of the lands of John W. Kirkland et ux, and Mrs. Laura Stephenson; thence with Mrs. Laura Stephenson's line and the center line of the road as it meanders approximately along a bearing and distance of N. 3° 45' E., 295 feet to the point of beginning, and containing 127. acres, more or less, subject to such rights as may be vested in the county or state to right of way for a public road.

A tract of land lying in Forneys Creek Township of Swain County, State of North Carolina, on the right side of the Little Tennessee River, approximately 2-3/4 miles northwest of Bushnell, and more particularly described as follows:

BEGINNING at a 16 inch Spanish oak tree at the top of Fork Ridge, a corner of the lands of the D. G. Fisher Heirs, and Oscar Kirkland, and the most northwesterly corner of the tract herein described; thence with Oscar Kirkland's line N. 85° 30' E., 2265 feet, crossing the North Fork of Chambers Creek at approximately 1950 feet, to a stone, a corner of the lands of Oscar Kirkland, A. L. A tract of land lying in Forneys Creek Township of Swain County, State of North Carolina, on the right side of the Tuckasegee River, approximately 2-3/4 miles northwest of the mouth of Forney's Creek, and more particularly described as follows:

BEGINNING AT a white oak stump in the south boundary line of the tract herein described, a corner of the lands of Arnold Kirkland, Oscar Kirkland, and the Bryson City Bank (an adjoining tract); thence with the Bank's line N. 18° 00' W., 885 feet, crossing Cherry Branch at approximately 50 feet, to a stone, a corner of the lands of the Bryson City Bank (an adjoining tract), Oscar Kirkland, and A. L. Kirkland; thence with A. L.  Bryson City Bank, dated November 2, 1931, recorded in Deed Book 60, page 116, in the office of the Register of Deeds
 for Swain County, North Carolina.

The Louis E. Fischer, named as one of the first parties hereto, is one and the same person as L. E. Fischer,
 grantee in the deed recorded in Deed Book 60, page 116, in the office of the Register of Deeds for Swain County,
 North Carolina.

TO HAVE AND TO HOLD the aforesaid tracts or parcels of land and all privileges and appurtenances thereto
 belonging, to the United States of America, its successors and assigns, to its own use and behoof forever.

And the said parties of the first part, for themselves, their heirs, successors, administrators and assigns,
 covenant with the said party of the second part, its successors and assigns that they are seized of said land and
 premises in fee, and have a right to convey the same in fee simple; that the same are free and clear from all
 encumbrances and that they will warrant and defend the title to same against the lawful claims of all persons
 whomsoever.

DECLARATION OF TAKING

No. 499

Tennessee Valley Authority, the authority empowered by law to acquire in the name of the United States of America the property described in the petition of similar title filed in this Court, hereby files this declaration of taking pursuant to the provisions of an act of Congress approved February 26, 1931, 46 Stat. 1421, c. 307, 40 U. S. C. A. 258a, and declares that said property is hereby taken for the use of the United States of America acting by and through its corporate creature and agent, the Tennessee Valley Authority, and further declares that:

1. The estate or interest taken in the said property for the said public use is the fee simple title, free of all liens, claims, and encumbrances, except as hereinafter shown.
