THIS DEED, Made this 20 day of March, 1944, by and between ANNA W. DeHART and husband, A. COWAN DeHART, of the County of Blount and State of Tennessee; ZEB SMITH and wife, ADDIE SMITH, of the County of Gaston and State of North Carolina; and JAMES H. SMITH and wife, IREAN SMITH, of the County of Mecklenburg and State of Virginia, as parties of the first part, and the UNITED STATES OF AMERICA as party of the second part:

WITNESSETH, that the said parties of the first part, in consideration of the sum of TWO HUNDRED FORTY-FIVE AND NO/100 DOLLARS (\$245.00) to them paid by the party of the second part, the receipt of which is hereby acknowledged, have bargained and sold, and by these presents do grant, bargain, sell and convey unto the UNITED STATES OF AMERICA, its successors and assigns, a certain tract or parcel of land, situate, lying and being in Swain County, State of North Carolina, and more particularly described as follows, to-wit:

A tract of land lying in Forneys Creek Township of Swain County, State of North Carolina, on the right side of the Little Tennessee River, approximately 2 1/4 miles northwest of Bushnell, and more particularly described as follows:

BEGINNING at a stone in the center line of a road, a corner of the lands of the Bryson City Bank, and John W. Kirkland et ux, and the most southeasterly point of the tract herein described; thence with John W. Kirkland's line S. 83° 30' W., 70 feet to a stone in the center line of the North Fork of Chambers Creek, a corner of the lands of John W. Kirkland et ux, and Oscar Kirkland; thence with Oscar Kirkland's line and the center line of the creek as it meanders upstream approximately 340 feet to a stone; thence, leaving the creek, S. 66° 00' E., 40 feet to a stone; thence N. 83° 00' E., 10 feet to a stone in the center line of a road, a corner of the lands of Oscar Kirkland, and the Bryson City Bank; thence with the Bank's line and the center line of the road as it meanders approximately along a bearing and distance of S. 3° 45' W., 295 feet to the point of beginning, and containing 0.7 acre, more or less.

It is understood and agreed that this conveyance is made subject to such rights as may be vested in the county or state to a right of way for a public road.

It is further understood and agreed that the bearings given in the above description are based on the North Carolina State Coordinate System, Lambert Projection, as established by the U. S. Coast and Geodetic Survey. The central meridian for this coordinate system is located at Longitude 79° 00' W.

The above described tract of land was acquired by Anna W. DeHart, Zeb Smith, and James H. Smith, three of the parties of the first part hereto, by virtue of intestate succession as heirs at law of Mrs. Laura Stephenson, deceased, grantee in the deed from Mrs. Lillie Wiggins, dated March 25, 1937, recorded in Deed Book 61, page 441, in the office of the Register of Deeds for Swain County, North Carolina.

TO HAVE AND TO HOLD the aforesaid tract or parcel of land and all privileges and appurtenances thereto belonging, to the UNITED STATES OF AMERICA, its successors and assigns, to its own use and behoof forever.

And the said parties of the first part, for themselves, their heirs, successors, administrators and assigns, covenant with the said party of the second part, its successors and assigns that they are seized of said land and premises in fee, and have right to convey the same in fee simple; that the same are free and clear from all encumbrances and that they will warrant and defend the title to same against the lawful claims of all persons whomsoever,

PILKINGTON, of the County of Campbell and State of Tennessee; JOHN N. pilkington of the County of Campbell and State of Maryland, and wife, ALICE ROSE PILKINGTON, of the County of Gaston and State of North Carolina, as parties of the first part, and the UNITED STATES OF AMERICA as party of the second part:

WITNESSETH, that the said parties of the first part, in consideration of the sum of SEVEN HUNDRED SEVENTY-TWO AND 89/100 Dollars (\$772.89) to them paid by the party of the second part, the receipt of which is hereby acknowledged, have bargained and sold, and by these presents do grant, bargain, sell and convey unto the UNITED STATES OF AMERICA, its successors and assigns, an undivided 1/2 interest in and to certain tracts or parcels of land, situate, lying and being in Swain County, State of North Carolina, and more particularly described as follows, to-wit:

TRACT NO. FR-1078

A tract of land lying in Forneys Creek Township of Swain County, State of North Carolina, on the right side of the Little Tennessee River, approximately 1 mile southwest of the confluence of the Little Laurel Creek and Indian Camp Creek tributaries of Chambers Creek, and more particularly described as follows:

BEGINNING at a 12 inch chestnut stump at the top of a ridge, a corner of the lands of J. E. Brooks, and George Washington Pilkington, and the most southerly point of the tract herein described; thence with George Washington Pilkington's line N. 38° 00' W., 1500 feet to a stake at the top of a ridge, a corner of the lands of George Washington Pilkington, and Guy Posey et ux; thence with Guy Posey's, Harve Dills', the W. M. Kirkland Heirs', and J. E.
