THIS DEED, Made this 4th day of December, 1944 by and between HAZEL CREEK LAND COMPANY, A Corporation of the County of Swain and State of North Carolina, as party of the first part, and the UNITED STATES OF AMERICA, as party of the second part;

WITNESSETH, that the said party of the first part, in consideration of the sum of TWENTY-SEVEN THOUSAND SIX HUNDRED FIFTY-FOUR AND 64/100 Dollars (\$27,654.64) to it paid by the party of the second part, the receipt of which is hereby acknowledged, has bargained and sold, and by these presents does grant, bargain, sell and convey unto the UNITED STATES

OF AMERICA, its successors and assigns, certain tracts or parcels of land, situate, lying and being in Swain County, State of North Carolina, and more particularly described as follows, to-wit:

TRACT FR-1131:

A tract of land lying in Forneys Creek Township of Swain County, State of North Carolina, between the Haw Gap Creek and Bone Valley Creek tributaries of Hazel Creek, approximately 3 1/4 miles north of Proctor, and more particularly described as follows:
