THIS DEED, Made this 14th day of September, 1944, by and between JOHN C. CALHOUN and wife, PEARL CALHOUN; VERAYLE CALHOUN FRANKS and husband, GWIN FRANKS; and INEZ CALHOUN, unmarried, of the County of Swain and State of North Carolina, as parties of the first part, and the UNITED STATES OF AMERICA as party of the second part:

WITNESSETH, that the said parties of the first part, in consideration of the sum of ONE THOUSAND SIXTY-SEVEN AND 52/100 Dollars (\$1,067.52) to them paid by the party of the second part, the receipt of which is hereby acknowledged, have bargained and sold, and by these presents do grant, bargain, sell and convey unto the UNITED STATES OF AMERICA, its successors and assigns, a certain tract or parcel of land, situate, lying and being in Swain County, State of North Carolina, and more particularly described as follows, to-wit:

A tract of land lying in Forneys Creek Township of Swain County, State of North Carolina, between the Bone Valley Creek and Walker Creek tributaries of Hazel Creek, approximately 3 3/4 miles northeast of Proctor, and more particularly described as follows:

BEGINNING at an 8 inch lynn tree, a corner of the lands of the Hazel Creek Land Company, and John Calhoun, and a northwest corner of the tract herein described; thence with John Calhoun's line South 88° 00' East, 360 feet to a 6 inch pine tree on Bone Valley Creek; thence along the creek North 6° 30' East, 410 feet to a rock; thence, leaving the creek, South 65° 30' East, 1740 feet to a point, a corner of the lands of John Calhoun, and J. G. Stikeleather et al; thence with J. G. Stikeleather's line South 57° 30' West, 1310 feet to a 36 inch chestnut tree; thence North 81° 00' West, 940 feet, crossing Bone Valley Creek at approximately 800 feet, to a stake, a corner of the lands of J. G. Stikeleather et al, and the J. E. Coburn Heirs; thence with the J. E. Coburn Heirs' and the Hazel Creek Land Company's line North 4° 00' East, 870 feet to the point of beginning, and containing 40 acres, more or less, subject to such rights as may be vested in the county or state to rights of way for public roads.

It is understood and agreed that the bearings given in the above description are based on the North Carolina State Coordinate System, Lambert Projection, as established by the U. S. Coast and Geodetic Survey. The central meridian for this coordinate system is located at Longitude 79° 00' West.

The above described land was acquired by the parties of the first part by virtue of a deed from G. G. Hall to John Calhoun and W. C. Calhoun, dated November 22, 1917, and recorded in Book 42, Page 574, in the office of the Register of Deeds of Swain County, North Carolina, and by virtue of intestate succession as heirs at law of W. C. Calhoun.

The foregoing conveyance is made subject to the unassigned dower of Noralee Calhoun in the undivided one-half interest of Verayle Calhoun Franks and Inez Calhoun.

TO HAVE AND TO HOLD the aforesaid tract or parcel of land and all privileges and appurtenances thereto belonging, to the UNITED STATES OF AMERICA, its successors and assigns, to its own use and behoof forever.

And the said parties of the first part, for themselves, theirheirs, successors, administrators and assigns, covenant with the said party of the second part, its successors and assigns that they are seized of said land and premises in fee, and have right to convey the same in fee simple; that the same are free and clear from all encumbrances and that they will warrant and defend the title to same against the lawful claims of all persons whomsoever.
