THIS DEED, made this the 18th day of January, 1944, by FRED MONTEITH and wife, ALICE MONTEITH, of Swain County, North Carolina, parties of the first part, to WALTER T. WIGGINS and wife, HETTIE WIGGINS, of Swain County, North Carolina, parties of the second part,

W I T N E S S E T H:

That the said parties of the first part, for and in consideration of the sum of ONE HUNDRED (\$100.00) DOLLARS to them paid by the said parties of the second part, the receipt whereof is hereby cacknowledged, have bargained and sold, and do, by these presents, give, grant, bargain, sell and convey unto the said parties of the second part, their heirs and assigns, forever, all of the following described tract or parcel of land, lying and being in Swain County, North Carolina, on the waters of Betts Branch, and bounded and described as follows, viz:

BEGINNING on a white oak stump on the North side of a branch about 231 feet from a ford in Betts Branch, and runs S. 8 W. 119 feet to a stake on top of a ridge; then up the ridge in a S. E. course 395 feet to a pine on top of a ridge; then in a N. E. course and with the top of the ridge as it meanders to a pine corner of Lizzie Wiggins; then with her line N. 68 W. 929 feet to the BEGINNING, containing 2 acres, more or less.

TO HAVE AND TO HOLD said premises, together with all the privileges and appurtenances thereto belonging, unto the said parties of the second part, their heirs and assigns, to their only use and behoof in fee simple forever.

And the said parties of the first part do, for themselves, their heirs, executors and administrators, covenant to and with the said parties of the second part, their heirs and assigns, that they are seized of said premises in fee, and have the full right and power to convey the same in fee simple; that the same are free and clear of any and all encumbrances; and that they do forever warrant and will forever defend the title to the same against the lawful claims of all persons whomscever.

THIS DEED, Made this 27 day of January, 1944, by and between WILLIAM HUNTER PILKINGTON and wife, LIZZIE CALHOUN PILKINGTON, of the County of Swain and State of North Carolina, as parties of the first part, and the UNITED STATES OF AMERICA, as party of the second part;

WITNESSETH, that the said parties of the first part, in consideration of the sum of FOUR THOUSAND FOUR HUNDRED SEVENTY-NINE AND 98/100 Dollars (\$4,479.98) to them paid by the party of the second part, the receipt of which is hereby acknowledged, have bargained and sold, and by these presents do grant, bargain, sell, and convey unto the UNITED STATES OF AMERICA, its successors and assigns, certain tracts or parcels of land, situate, lying and being in Swain County, State of North Carolina, and more particularly described as follows, to-wit:

TRACT NO. FR-1192

A tract of land lying in Forneys Creek Township of Swain County, State of North Carolina, on the right side of the Little Tennessee River, approximately 2 miles northeast of Calhoun Island, and more particularly described as follows:

Beginning at a 30 inch black gum tree in the east boundary line of the tract herein described, a corner of the lands of John Pilkington, Flora Hall, and N. A. Pilkenton; thence with N. A. Pilkenton's line S. 46° 00' W., 380 feet to a 20 inch spanish oak tree at a rock; thence with a hacked line S. 36° 00' E., 530 feet to a point; thence S. 38° 00' E., 450 feet to a point; thence, leaving the hacked line, S. 79° 00' E., 110 feet to a stake; thence S. 3° 00' E., 405 feet to a rock, a corner of the lands of N. A tract of land lying in Forneys Creek Township of Swain County, State of North Carolina, on the right side of the Little Tennessee River, approximately 2 1/4 miles east of Calhoun Island, and more particularly described as follows:

Beginning at a stake, a corner of the lands of A. J. Posey et ux May, and A. J. Posey et ux L. M.; thence with A. J. Posey et ux L. M.'s line N. 86° 00' W., 90 feet, crossing Pilkey Creek at approximately 30 feet, to a point in the center line of a road, a corner of the lands of A. J. Posey et ux L. M., and G. J. Welch et ux; thence with G. J. Welch's, and W. H. Beginning at a stake at the top of a ridge, a corner of the lands of Lee Hering et ux, and Sarah Crisp; thence with Sarah Crisp's line and a hacked line N. 62° 00' E., 1300 feet to a point; thence S. 84° 00' E., 260 feet to a point; thence N. 72° 00' E., 396 feet to a point; thence N. 87° 30' E., 659 feet to a stake, a corner of the lands of Sarah Crisp, and N. A. & Laura Pilkington; thence leaving the hacked line and with N. A. & Laura Pilkington's line S. 5° 00' E., 190 feet to a point; thence S. 23° 00' E., 264 feet to a point; thence S. 51° 00' E., 330 feet to a point; thence S. 43° 00' E., 410 feet to a point in the center line of a road witnessed by a tree, a corner of the lands of N. Coast and Geodetic Survey. The central meridian for this coordinate system is located at Longitude 79° 00' W.

The above described land designated as Tract No. FR-1193 was acquired by Hunter Pilkington and wife, Lizzie Pilkington, first parties hereto, by virtue of the deed from L. J. Herron and wife, dated January 28, 1931, of record in Deed Book 57, page 183, in the office of the Register of Deeds for Swain County, North Carolina.

The above described land designated as Tract No. FR-1201 was acquired by W. H. Pilkington, one of the first parties hereto, by virtue of the deed from Nancy J. Pilkington, dated April 30, 1931, of record in Deed Book 57, page 217, in the office of the Register of Deeds for Swain County, North Carolina.

The William Hunter Pilkington who is named as one of the first parties hereto is one and the same person as the W. H. Pilkington who was named as grantee in the instruments of record in Book 54, page 351, and Book 57, page 217, and the Hunter Pilkington who was named as grantee in the deed of record in Deed Book 57, page 183, in the office of the Register of Deeds for Swain County, North Carolina.

The Lizzie Calhoun Pilkington who is named as one of the first parties hereto is one and the same person as the Lizzie Pilkington who was named as grantee in the deed of record in Deed Book 57, page 183, in the office of the Register of Deeds for Swain County, North Carolina.

The undersigned, NATHAN A. PILKINGTON, who is the same person as N. A. Pilkington, and wife, LAURA PILKINGTON, for a valuable consideration to them in hand paid, the receipt of which is hereby acknowledged, join in the execution of this instrument for the purpose of conveying their interest in the mill site located on the above described tract FR-1193, which interest was reserved in the deed to L. J. Herron et ux, dated December 6, 1928, recorded in Deed Book 55, page 376, in the office of the Register of Deeds of Swain County, North Carolina.
