

TENNESSEE VALLEY AUTHORITY WARRANTY DEED

STATE OF NORTH CAROLINA—SWAIN COUNTY (DOCUMENTARY STAMPS ATTACHED \$1.65)
THIS DEED, Made this 7th day of December, 1943, by and between

HATTIE GUNTER, a widow,

of the County of Swain and State of North Carolina, as party of the first part, and the UNITED STATES OF AMERICA as party of the second part: WITNESSETH, That the said party of the first part, in consideration of the sum of One thousand ninety eight and 30/100 - - - - - Dollars (\$1,098.30) to her paid by the party of the second part, the receipt of which is hereby acknowledged, has bargained and sold, and by these presents does grant, bargain, sell and convey unto the UNITED STATES OF AMERICA, its successors and assigns, a certain tract or parcel of land, situate, lying and being in Swain County, State of North Carolina, and more particularly described as follows, to-wit:

A tract of land lying in Forneys Creek Township of Swain County, State of North Carolina, on the right side of Hazel Creek, approximately 1/4 mile north of the State Highway No. 288 bridge across Hazel Creek, and more particularly described as follows:

BEGINNING at a 12 inch hickory tree, a corner to the land of the J. E. Coburn Heirs, and the most westerly point of the tract herein described; thence with the J. E. Coburn Heirs' line North 61° 00' East, 1110 feet, passing a 45 inch poplar tree at approximately 800 feet, to a point at the top of a ridge, a corner of the lands of the J. E. Coburn Heirs, and the Hazel Creek Land Company, thence with the Company's line and the top of the ridge as it meanders approximately along the following bearings and distances:

South 15° 00' West, 640 feet to an 8 inch spanish oak tree, South 67° 00' West, 180 feet, to a 10 inch black gum tree; thence, leaving the ridge, South 12° 00' West, 635 feet to a 6 inch maple tree; thence South 69° 00' West, 210 feet to a point, a corner of the lands of the Hazel Creek Land Company, and the J. E. Coburn Heirs; thence with the J. E. Coburn Heirs' line North 21° 00' West, 885 feet to the point of beginning, and containing 13.4 acres, more or less.

It is understood and agreed that the bearings given in the above description are based on the North Carolina State Coordinate System, Lambert Projection, as established by the U. S. Coast and Geodetic Survey. The central meridian for this coordinate system is located at Longitude 79° 00' West.

The above described land was acquired by the party of the first part herein by virtue of a deed from L. B. Calhoun and wife, Iva Calhoun, dated March 15, 1942, and recorded in Book 64, Page 504, in the office of the Register of Deeds of Swain County, North Carolina.

TO HAVE AND TO HOLD the aforesaid tract or parcel of land and all privileges and appurtenances thereto belonging, to the UNITED STATES OF AMERICA, its successors and assigns, to its own use and behoof forever. And the said party of the first part, for herself, her heirs, successors, administrators and assigns, covenant s with the said party of the second part, its successors and assigns that she is seized of said land and premises in fee, and has right to convey the same in fee simple; that the same are free and clear from all encumbrances and that she will warrant and defend the title to same against the lawful claims of all persons whomsoever.
