

TENNESSEE VALLEY AUTHORITY WARRANTY DEED

THIS DEED, Made this 4 day of March, 1944, by and between

WILLIAM HAMPTON COLE and wife, JULIA COLE

of the County of Swain and State of North Carolina, as parties of the first part, and the UNITED STATES OF AMERICA as party of the second part: WITNESSETH, That the said parties of the first part, in consideration of the sum of SIX HUNDRED FORTY-FOUR AND 30/100-----Dollars (\$644.30) to them paid by the party of the second part, the receipt of which is hereby acknowledged, have bargained and sold, and by these presents do grant, bargain, sell and convey unto the UNITED STATES OF AMERICA, its successors and assigns, a certain tract or parcel of land, situate, lying and being in Swain County, State of North Carolina, and more particularly described as follows, to-wit:

A tract of land lying in Forneys Creek Township of Swain County, State of North Carolina, on the right side of the Tuckasegee River, approximately 2 miles southwest of the confluence of Indian and Noland Creeks, and more particularly described as follows;

BEGINNING at a 24 inch red oak tree at the top of Tunnel Ridge, a corner of the lands of A. C. Hyatt et ux, and Phillip G. Rust, and the most northerly point of the tract herein described; thence with Phillip G. Rust's line and the top of the ridge as it meanders in a southerly direction approximately 1250 feet to a stake, a corner of the lands of Phillip G. Rust, and the A. J. Hall Heirs; thence with the A. J. Hall Heirs' line and the top of a ridge as it meanders approximately along a bearing and distance of S. 29° 00' W., 1210 feet to a point, a corner of the lands of the A. J. Hall Heirs, E. O. & A. J. Hall, and W. H. & Julyan Cole; thence with W. H. & Julyan Cole's line N. 23° 00' W., 1880 feet to a point at the top of a ridge, a corner of the lands of W. H. & Julyan Cole, and A. C. Hyatt et ux; thence with A. C. Hyatt's line and the top of the ridge as it meanders approximately along the following bearings and distances: N. 71° 00' E., 390 feet, N. 36° 00' E., 320 feet to stake, N. 69° 00' E., 350 feet to the point of beginning, and containing 34 acres, more or less.

It is understood and agreed that the bearings given in the above description are based on the North Carolina State Coordinate System, Lambert Projection, as established by the U. S. Coast and Geodetic Survey. The central meridian for this coordinate system is located at Longitude 79° 00' W.

The above described tract of land was acquired by William Hampton Cole, one of the parties of the first part, by deed from H. E. Cunningham and wife, F. C. Cunningham, dated February 4, 1924, recorded in Deed Book 45, page 539, in the office of the Register of Deeds for Swain County, North Carolina.

It is understood and agreed that the parties of the first part grant and convey the above described tract of land subject to an undivided 1/12 interest in and to the minerals as may be outstanding in third parties by virtue of intestate succession as heirs of William N. Cooper, deceased, the said William N. Cooper having acquired the same by virtue of the deed from John B. Allison, dated December 16, 1881, recorded in Deed Book 3, page 233, in the office of the Register of Deeds for Swain County, North Carolina. And the parties of the first part, for the consideration herein set out, hereby convey any and all right, title, and interest which they may now have, or may hereafter have, in and to the minerals contained in the above described tract of land by way of reversion, remainder, adverse possession, prescription, or otherwise.

The William Hampton Cole who is named as one of the parties of the first part is one and the same person as the Hampton Cole who was named as grantee in the deed of record in Deed Book 45, page 539, in the office of the Register of Deeds for Swain County, North Carolina.

TO HAVE AND TO HOLD the aforesaid tract or parcel of land and all privileges and appurtenances thereto belonging, to the UNITED STATES OF AMERICA, its successors and assigns, to its own use and behoof forever. And the said parties of the first part, for themselves, their heirs, successors, administrators and assigns, covenant with the said party of the second part, its successors and assigns that they are seized of said land and premises in fee, and have right to convey the same in fee simple; that the same are free and clear from all encumbrances and that they will warrant and defend the title to same against the lawful claims of all persons whomsoever.
