Witnesseth, That the said Maggie Jenkins Cable, one of the first parties hereto, in consideration of the sum of Thirty-eight and 12/100 Dollars (\$38.12) to her paid by the party of the second part, the receipt of which is hereby acknowledged, has bargained and sold, and by these presents does grant, bargain, sell and convey unto the United States of America, its successors and assigns, her unassigned right of dower in and to the hereinafter described tract of land; and Raymond E. Cable and wife, Mary Welch Cable, parties of the first part, for and in consideration of the sum of Ninety-eight and 72/100 Dollars (\$98.72) to them paid by the party of the second part, the receipt of which is hereby acknowledged, have bargained and sold, and by these presents do grant bargain, sell and convey unto the United States of America, its successors and assigns, an undivided 1/3 interest subject to the unassigned right of dower of Maggie Jenkins Cable in and to a certain tract or parcel of land, situate, lying and being in Swain County, State of North Carolina, and more particularly described as follows, to-wit:

A tract of land lying in Forneys Creek Township of Swain County, State of North Carolina, on the right side of the Little Tennessee River, approximately 1 1/4 miles south of Proctor, and more particularly described as follows:

WITNESSETH, That the said parties of the first part, in consideration of the sum of Ninety-Eight and 73/100 Dollars (\$98.73) to them paid by the party of the second part, the receipt of which is hereby acknowledged, have bargained and sold, and by these presents do grant, bargain, sell and convey unto the United States of America, its successors and assigns, an undivided 1/3 interest, subject to the unassigned right of dower of Maggie Jenkins Cable, in and to a certain tract or parcel of land, situate, lying and being in Swain County, State of North Carolina, and more particularly described as follows, to-wit:
