WARRANTY DEED

THIS DEED, Made this 21st day of July, 1943, by and between GEO. P. MONTEITH and wife, MAUDE M. MONTEITH, of the County of Lane, and State of Oregon; RUFUS B. MONTEITH, an unmarried man; NANCY LEANAH MONTEITH, an unmarried woman; FRED L. MONTEITH and wife, MAMIE G. MONTEITH; MARGIE M. GIBBY and husband, D. H. GIBBY, EUGENE MONTEITH and wife, MAE O. MONTEITH, and MARY JOSEPHINE MONTEITH, a widow, of the County of Swain and State of North Carolina, as parties of the first part, and the UNITED STATES OF AMERICA as party of the second part:

WITNESSETH, that the said parties of the first part, in consideration of the sum of EIGHT THOUSAND ONE HUNDRED FORTY-FOUR AND 10/100 Dollars (\$8,144.10) to them paid by the party of the second part, the receipt of which is hereby acknowledged, have bargained and sold, and by these presents do grant, bargain, sell and convey unto the UNITED STATES OF AMERICA, its successors and assigns, a certain tract or parcel of land, situate, lying and being in Swain County, State of North Carolina, and more particularly described as follows, to-wit:

A tract of land lying in Forneys Creek Township of Swain County, State of North Carolina, on the right side of the Tuckasegee River, approximately 1 1/4 miles north of Bushnell, and more particularly described as follows:

BEGINNING at a stone, a corner of the lands of E. M. Anthony, and Caro Lee Cole, and the most northeasterly point of the tract herein described; thence with Caro Lee Cole's line South 2° 00' East, 2525 feet to a 12 inch hickory tree, a corner of the lands of Caro Lee Cole, and the Nantahala Power & Light Company; thence with the said Company's line North 20° 00' West, 620 feet to a bed rail and a chestnut stump; thence South 24° 00' West, 430 feet

to a bed iron and chestnut snag; thence South 5° 00' East, 220 feet to a pipe witnessed by a 50 inch chestnut stump; thence South 6° 00' East, 830 feet to a point in a fence line, a corner of the lands of the Nantahala Power & Light Company, and the Forney Creek Baptist Church Cemetery; thence with the said Cemetery's line and the fence line South 51° 00' West, 70 feet to a fence angle; thence South 7° 00' East, 160 feet to a fence angle; thence South 38° 00' East, 65 feet to a 14 inch hickory tree, a corner of the lands of the Forney Creek Baptist Church Cemetery, and the Nantahala Power & Light Company; thence with the said Company's line, leaving the fence line, South 42° 00' West, 310 feet to a point in the center line of Montieth Branch, a corner of the lands of the Nantahala Power & Light Company, and D. E. Gunter; thence with D. E. Gunter's line and the center line of the branch as it meanders upstream approximately 160 feet to a point; thence, leaving the branch, South 25° 00' East, 140 feet to an iron stake, a corner of the lands of D. E. Gunter, the Nantahala Power & Light Company, and D. E. Gunter; thence with D. E. Gunter's line South 20° 00' West, 620 feet to a 12 inch pine tree, a corner of the lands of D. E. Gunter, and the J. E. T. Welch Heirs; thence with the J. E. T. Welch Heirs' line South 85° 00' West, 170 feet to a point, a corner of the lands of the J. E. T. Welch Heirs, and S. C. Welch; thence with S. C. Welch's line South 86° 30' West, 1075 feet to a point; thence South 76° 00' West, 540 feet, crossing Montieth Branch at approximately 180 feet, to a point; thence South 75° 00' West, 500 feet to a point, a corner of the lands of S. C. Welch, and W. M. Anthony et ux; thence with W. M. Anthony's line North 22° 30' East, 1330 feet to a bed rail; thence South 75° 00' West, 655 feet to a point, a corner of the lands of W. M. Anthony et ux, and Ivan Anthony et ux; thence with Ivan Anthony's line North 48° 30' West, 1360 feet to a point, a corner of the lands of Ivan Anthony et ux, W. W. Shook, and R. E. L. Kirkland; thence with R. E. L. Kirkland's line North 4° 00' East, 730 feet to a bed rail, a corner of the lands of R. E. L. Kirkland, and H. B. Anthony; thence with H. B. Anthony's line South 85° 00' East, 1390 feet to a point; thence South 83° 00' East, 1605 feet to an iron pin; thence with a fence line for the last approximate 240 feet North 8° 00' East, 2600 feet to a rifle barrel, a corner of the lands of H. B. Anthony, and E. M. Anthony; thence, leaving the fence line, with E. M. Anthony's line South 87° 00' East, 690 feet to the point of beginning, and containing 205. acres, more or less, subject to such rights as may be vested in the county or state to rights of way for public roads.

It is understood and agreed that the bearings given in the above description are based on the North Carolina State Coordinate System, Lambert Projection, as established by the U. S. Coast and Geodetic Survey. The central meridian for this coordinate system is located at Longitude 79° 00' West.

The above described land was conveyed to A. J. Monteith by deeds from A. J. Parris et ux, dated February 11, 1896, and recorded in Book 56, Page 294; from W. C. Welch et ux, dated December 19, 1892, and recorded in Book 21, Page 532; and from John M. Thrash, dated December 23, 1902, and recorded in Book 20, Page 279, all of said deeds being recorded in the office of the Register of Deeds of Swain County, North Carolina.

It is understood and agreed that the Parties of the First Part grant and convey the above described tract of land subject to such right, title, and interest in and to the minerals as may be outstanding in third parties by virtue of the reservation contained in that certain deed from W. C. Welch and wife, Elizabeth Welch, to A. J. Monteith, dated December 19, 1892, and recorded in Book 21, Page 532, in the office of the Register of Deeds for Swain County, North Carolina. And the Parties of the First Part, for the consideration herein set out, hereby convey any and all right, title, and interest which they may now have or may hereafter have, in and to the minerals contained in the above described tract of land by way of reversion, remainder, adverse possession, prescription, or otherwise.

TO HAVE AND TO HOLD the aforesaid tract or parcel of land and all privileges and appurtenances thereto belonging, to the UNITED STATES OF AMERICA, its successors and assigns, to its own use and behoof forever.

And the said parties of the first part, for themselves, their heirs, successors, administrators and assigns, covenant with the said party of the second part, its successors and assigns that they are seized of said land and premises in fee, and have right to convey the same in fee simple; that the same are free and clear from all encumbrances and that they will warrant and defend the title to same against the lawful claims of all persons whomsoever.
