WARRANTY DEED

STATE OF NORTH CAROLINA

SWAIN COUNTY

THIS DEED, Made this 12 day of November, 1943, by and between JOSEPH H. McCLURE and wife, NOLA DILLS McCLURE; ROXIE CHAMBERS McCLURE, a widow; ROXIE K. KIRKLAND and husband, JACK KIRKLAND; ETTA R. KIRKLAND, an unmarried woman; ANNIE KIRKLAND CALHOUN and husband, CLIFFORD CALHOUN; MINNIE KIRKLAND FLEMING and husband, HUBERT D. FLEMING, by ETTA R. KIRKLAND, their attorney in fact; and LON KIRKLAND, as guardian for CLARENCE KIRKLAND and MATILDA KIRKLAND, minors, of the County of Swain and State of North Carolina, as Parties of the First Part, and the UNITED STATES OF AMERICA, as Party of the Second Part:

WITNESSETH, that the said Parties of the First Part, in consideration of the sum of THREE HUNDRED FIFTY-TWO AND 08/100 Dollars (\$352.08) to them paid by the Party of the Second Part, the receipt of which is hereby acknowledged, have bargained and sold, and by these presents do grant, bargain, sell, and convey unto the UNITED STATES OF AMERICA, its successors and assigns, an undivided 28/144 interest in a certain tract of land, situate, lying and being in Swain County, State of North Carolina, and more particularly described as follows, to wit:

A tract of land lying in Forneys Creek Township of Swain County, State of North Carolina, on the right side of the Little Tennessee River, approximately 2 miles west of the Bushnell Depot, and more particularly described as follows:

Beginning at a point in the center line of Chambers Creek at the mouth of a drain, a corner of the lands of W. W. Crisp, and Luther Anthony et al; thence with Luther Anthony's line and with a stone fence for the last approximate 360 feet South 28° 00' East, 410 feet, crossing a public road at approximately 30 feet, to a point; thence, leaving the stone fence, South 42° 00' East, 1215 feet to a point, a corner of the lands of Luther Anthony et al, and the Nantahala Power & Light Company; thence with the said Company's line South 34° 22' West, 240 feet to a point (prev. desc. as a pipe); thence South 35° 34' West, 548 feet to a point (prev. desc. as an iron pipe witnessed by a post oak stump); thence South 82° 05' West, 1677 feet to a point (prev. desc. as an iron pipe witnessed by a pine stump); thence North 3° 23' West, 595 feet to a point (prev. desc. as an iron pipe witnessed by a 16 inch white oak tree); thence North 3° 00' West, 493 feet to a 10 inch buckeye tree; thence North 11° 35' West, 159 feet to a point (prev. desc. as a 7 inch persimmon tree) on the north edge of a public road; thence North 7° 38' West,

76 feet to a point (prev. desc. as a pipe); thence North 82° 25' East, 118 feet to a point (prev. desc. as a maple tree); thence North 17° 02' East, 18 feet to a point in the center line of Chambers Creek, a corner of the lands of the Nantahala Power & Light Company, and W. W. Crisp; thence with W. W. Crisp's line and the center line of the creek as it meanders upstream approximately 1630 feet to the point of beginning, and containing 65 acres, more or less, subject to such rights as may be vested in the county or state to a state road leading from State Highway No. 288 up Chambers' Creek which affects approximately 1.8 acres.

It is understood and agreed that the bearings given in the above description are based on the North Carolina State Coordinate System, Lambert Projection, as established by the U. S. Coast and Geodetic Survey. The central meridian for this coordinate system is located at Longitude 79° 00' West.

An undivided 28/144 interest in the above described land was acquired by the parties of the first part by virtue of descent from W. J. McClure, who acquired title by deed from W. W. Crisp and wife, Minnie Crisp, recorded in Book 57, Page 59, in the office of the Register of Deeds of Swain County, North Carolina.

It is understood and agreed that the parties of the first part grant and convey the above described land subject to such right, title, and interest in and to the minerals as may be outstanding in third parties by virtue of the reservation contained in the deed from C. W. Slagle and wife, Myra L. Slagle, to S. S. Collins, dated February 19, 1907, and recorded in Book 28, Page 584, in the office of the Register of Deeds of Swain County, North Carolina. And the parties of the first part, for the consideration herein set out, hereby convey any and all right, title, and interest which they may now have or may hereafter have, in and to the minerals contained in the above described land by way of reversion, remainder, adverse possession, prescription, or otherwise.

Lon Kirkland, as guardian of Clarence Kirkland and Matilda Kirkland, having qualified as such on August 20, 1943, joins in this conveyance to convey all the right, title, and interest of the said Clarence Kirkland and Matilda Kirkland, minors, in the property aforesaid, by authority and direction of the decree entered in Special Proceeding Docket 4, Page 479, Superior Court of Swain County, North Carolina, styled "In the Matter of Clarence Kirkland and Matilda Kirkland, by their guardian, Lon Kirkland, Ex Parte", to which record reference is made, hereby acknowledging receipt of the purchase money as in said decree provided.

TO HAVE AND TO HOLD the aforesaid tract of land and all privileges and appurtenances thereto belonging, to the UNITED STATES OF AMERICA, its successors and assigns, to its own use and behoof forever.

And the said parties of the first part, for themselves, their heirs, successors, administrators and assigns, covenant with the said party of the second part, its successors and assigns that they are seized of said land and premises in fee, and have right to convey the same in fee simple; that the same are free and clear from all encumbrances, and that they will warrant and defend the title to same against the lawful claims of all persons whomsoever.


