THIS DEED, Made this 26th day of November, 1943, by and between LAURA M. CLARK, unmarried; LORA MAE CLARK POSEY and husband, A. J. POSEY, of Swain County, North Carolina; HELEN CLARK HAMILTON and husband, VINCENT HAMILTON, of Graham County, North Carolina; LEILA CLARK SIMS and husband, PAUL SIMS; HERMA CLARK DALRYMPLE, and husband, ARNOLD DALRYMPLE; BERTHA CLARK McNABB, and husband, CLIFFORD McNABB, of Cherokee County, North Carolina; OBED T. CLARK and wife, OPALIE MOODY CLARK, of Jackson County, North Carolina; PLATO CLARK and wife, EDNA ANTHONY CLARK, Blount County, Tennessee; ELIZABETH POSEY BRAMBLETT and husband, FLOYD BRAMBLETT; of Murray County, Georgia and WILLIAM D. POSEY and wife, OBER S. POSEY, of Whitfield County, Georgia, as parties of the first part, and the UNITED STATES OF AMERICA as party of the second part:

WITNESSETH, that the said parties of the first part, in consideration of the sum of TWO THOUSAND TWO HUNDRED SEVENTY SEVEN and 81/100 Dollars (\$2,277.81) to them paid by the party of the second part, the receipt of which is hereby acknowledged, have bargained and sold, and by these presents do grant, bargain, sell and convey unto the UNITED STATES OF AMERICA, its successors and assigns, a certain tract or parcel of land, situate, lying and being in Swain County, State of North Carolina, and more particularly described as follows, to-wit:

A tract of land lying in Forneys Creek Township of Swain County, State of North Carolina, on the right side of the Little Tennessee River, approximately 1-3/8 miles northwest of the mouth of Stecoah Creek, and more particularly described as follows:

Beginning at the point of confluence of Poseys Branch and Hubbard Mill Creek, a corner of the lands of Joseph Collins, and the J. M. Crisp Heirs; thence with the J. M. Crisp Heirs' line and the center line of the creek as it meanders downstream approximately 50 feet to a point; thence, leaving the creek, South 31° 00' West, 260 feet to a point (prev. desc. as a rock) in the center line of the creek, a corner of the lands of the J. M. Crisp Heirs, the Nantahala Power & Light Company, and Guy Posey et al; thence with Guy Posey's line North 85° 04' West, 191 feet to a point (prev. desc. as a stake), a corner of the lands of Guy Posey et al, and the Nantahala Power & Light Company; thence with the Company's line North 5° 18' East, 174 feet to a point (prev. desc. as a 10 inch locust stump) at the north edge of State Highway No. 288; thence North 84° 23' West, 390 feet to a point in the center line of the highway, a corner of the lands of the Nantahala Power & Light Company, and Guy Posey et al; thence with Guy Posey's line North 84° 23' West, 714 feet to a point (prev. desc. as a 15 inch post oak tree) at the top of a ridge, a corner of the lands of Guy Posey et al, the Nantahala Power & Light Company, and Lee Herron et ux; thence with Lee Herron et ux's line and the top of the ridge as it meanders approximately along the following bearings and distances:

North 8° 00' West, 365 feet;

North 34° 00' West, 270 feet;

North 6° 00' East, 555 feet;

North 20° 00' West, 520 feet to a point at the intersection of ridges witnessed by trees, a corner of the lands of Lee Herron et ux, and Lee Hering et ux; thence with Lee Hering's line and the top of a ridge as it meanders approximately along the following bearings and distances:

South 86° 00' East, 420 feet;

North 67° 00' East, 290 feet;

South 85° 00' East, 520 feet;

North 69° 00' East, 670 feet to a pine stump;

South 24° 00' East, 150 feet to a stake; thence, leaving the top of the ridge, South 54° 00' East, 240 feet to a 2 inch white oak tree, a corner of the land of Lee Hering et ux, and the land in dispute between Lee & Lily Hering and the W. H. Clark Heirs; thence with the line of the land in dispute between Lee & Lily Hering and the W. H. Clark Heirs South 32° 00' West, 655 feet to a white oak stump; thence North 75° 00' East, 200 feet to a 3 inch white oak tree, a corner of the land in dispute between Lee & Lily Hering and the W. H. Clark Heirs, and the land of Lee Hering et ux; thence with Lee Hering's line North 60° 00' East, 190 feet to a point at the top of a ridge, a corner of the lands of Lee Hering et ux, and Guy Posey et al; thence with Guy Posey's line and the top

of the ridge as it meanders approximately along the following bearings and distances: South 11° 00' East, 435 feet; South 16° 00' West, 315 feet to a 12 inch birch tree; thence, leaving the top of the ridge, North 75° 00' East, 80 feet to a point in the center line of State Highway No. 288, a corner of the lands of Guy Posey et al, and Joseph Collins; thence with Joseph Collins' line and the center line of the highway as it meanders in a general south-westerly direction approximately 430 feet to a point; thence, leaving the highway, South 54° 00' East, 130 feet, passing a 14 inch pine tree at 30 feet, to the point of beginning, and containing 70. acres, more or less, subject to such rights as may be vested in the county or state to State Highway No. 288 which affects approximately 1.6 acres.

It is understood and agreed that the bearings given in the above description are based on the North Carolina State Coordinate System, Lambert Projection, as established by the U. S. Coast and Geodetic Survey. The central meridian for this coordinate system is located at Longitude 79° 00' West.

Being the property devised to the first parties hereto under the will of W. H. Clark, deceased, of record in Will Book , Page , in the office of Clerk of Superior Court, Swain County, North Carolina; and being also the property conveyed to W. H. Clark by the following deeds of record in the office of the Register of Deeds of Swain County, North Carolina.

(2) Deed executed by J. H. Crisp et ux, Tinie, dated December 26, 1899, and recorded in Deed Book 28, Page 194.

TO HAVE AND TO HOLD the aforesaid tract or parcel of land and all privileges and appurtenances thereto belonging, to the UNITED STATES OF AMERICA, its successors and assigns, to its own use and behoof forever.

And the said parties of the first part, for themselves, their heirs, successors, administrators and assigns, covenant with the said party of the second part, its successors and assigns that they are seized of said land and premises in fee, and have right to convey the same in fee simple; that the same are free and clear from all encumbrances and that they will warrant and defend the title to same against the lawful claims of all persons whomsoever.
