This cause coming on to be heard before the undersigned Clerk of the Superior Court of Buncombe County, North Carolina, on this the 20th day of April, 1931, and being heard, and the Court having found, and hereby finding, the facts as follows; to-wit:

1. That this action and proceeding is duly constituted in this Court, that is to say, that summons herein was duly issued on the 2nd day of June, 1930, and that the duly varified petition of the State of North Carolina was on said date duly filed in this Court, and that said summons and said duly varified petition herein have been duly served upon the respondents herein, and every of them, in all respects as required by law, and that the notice required by Chapter 48, Section 19, of the Public Laws of North Carolina, Session of 1927, has been duly given and published in all respects as therein required, whereby all persons whom it may concern and all persons having or claiming any estate or interest in the lands and premises sought to be condemned in this proceeding have been duly notified and required to appear in this proceeding at the time and place therein mentioned and to make such answer, defence or plea as they may be advised; and that certain of said respondents shown in said petition and said summons to be non-residents of the State of North Carolina have been duly served by publication, as required

by law, and that the time for answering was extended by an order made by the Clerk of the Superior Court of Buncombe County, allowing all of the respondents to appear and answer the petition on or before July 21, 1930; that Hipps & Burgin, Oscar McDonald and R.L.Burgin filed an answer in said proceeding, date June 11, 1930, setting up their claim to the interest in the lands described in Paragraph 13 of the petition, being the lands owned and claimed by J.D.Smith and wife, Emma Smith; that N.A.Hall filed an answer in said proceeding, dated June 26, 1930, setting up his claim to an interest in the lands described in Paragraph 13 of the petition, being the lands owned and claimed by J.D.Smith and wife, Emma Smith; that W.H.Duncan filed an answer in said proceeding, dated July 7, 1930, setting up his claim to an interest in the lands described in Paragraph 13 of the petition, being the lands owned and claimed by J.D.Smith and wife, Emma Smith; that J.L.Reeves and H.W.Tidmarsh filed an answer in said proceeding, dated July 9, 1930, setting up their claim to an interest in the lands described in Paragraph 13 of the petition, being the lands owned and claimed by J.D.Smith and wife, Emma Smith; that J.B.Smith and wife, Emma Smith filed an answer in said proceeding, dated July 25, 1930, setting up their claim to the lands described in Paragraph 13 of the Petition, and being Tracts Nos. 73 and 75 of the survey made by the North Carolina Park Commission; that the Heirs at law of J.H.Connor appeared and filed an answer in this proceeding, dated July 25, 1930, setting up their claim to the lands described in Paragraph 11 of the petition, being Tract No. 50 of the survey made by the North Carolina Park Commission; that the Heirs at law of W.E.Queen filed an answer in this proceeding, dated July 25, 1930, setting up their claim to the lands described in Paragraph 5 of the petition, being Tract No. 11 of the survey made by the North Carolina Park Commission; that L.S.Connor and wife Minnie Connor filed an answer in this cause, dated July 25, 1930, setting up their claim to the lands described in Paragraph 12 of the petition, being Tract No. 54 of the survey made by the North Carolina Park Commission; all of which will more particularly appear by the records and files of the Court in this cause, and the Court hereby finds as a fact that no other person, firm or corporation whomsoever has appeared herein or has, in any manner, asserted any interest or claim in the subject matter of this action and proceeding.

2. That heretofore, to-wit, on the 31st day of January, 1931, (the time for answering having fully elapsed and expired as to all and every of the respondents summoned herein and of all other persons whom it may concern notified by the above receipted publication and notice herein), the undersigned Clerk of the Superior Court of Buncombe County, North Carolina, duly made and entered in interlocutory judgment and order in this cause, whereby it was duly ordered and adjudged, inter alia, that FRANK JORDAN, E. GROVER ROBINSON and T.LUTHER MANEY be, and they were, duly appointed commissioners by the Court, and they were required fairly and impartially to appraise the lands and interests in lands mentioned in the petition herein, and to ascertain and determine the compensation which ought justly to be made by the petitioner to the party or parties owning or interested in the real estate so appraised by them, and to make a report to the Court therein, according to law, and said commissioners were required, before entering upon their duties, to take and subscribe an oath, in form of law, that they would fairly and impartially assess and award the compensation aforesaid, as required by law, all of which will more fully appear by reference to said order, and all and singular the requirements thereof, as the same may appear upon the records and files of this cause, and the said commissioners proceeded, having first been duly sworn, conformably to the provisions and requirements of said order.

to duly appraise the same, as required by said order, and thereafter, to-wit, on the 27th day of March, 1931, the said commissioners made written report of their said proceedings and returned the same to the Court, together with the evidence taken by them, as required by law and <sup>the</sup> order aforesaid, all of which will more particularly appear by the records of the proceedings in this cause, which are hereby particularly referred to.

3. That said commissioners and appraisers, by their report in the last preceding paragraph hereof mentioned, appraised, ascertained and ~~and~~ determined the compensation which ought justly to be made by the petitioner or the party or parties owning or interested in the lands and premises described in the petition and so appraised by them separately, as follows:-

(a) That they estimated, appraised and assessed the compensation and damages for the first tract described in the petition in Paragraph 5 thereof, being the lands owned and claimed by the Heirs at law of W.E. Queen, and being Tract No. 11 of the survey made by the North Carolina Park Commission, at the sum of TWELVE THOUSAND and 00/100 DOLLARS (\$12,000.00).

(b) That they estimated, appraised and assessed the compensation and damages for the second tract described in said petition in Paragraph 6 thereof, being the lands owned and claimed by John C. Reagan and wife, Melinda Reagan, and being Tract No. 24 of the survey made by the North Carolina Park Commission, at the sum of EIGHT THOUSAND and 00/100 DOLLARS (\$8,000.00).

(c) That they estimated, appraised, and assessed the compensation and damages for the third tract described in said petition in Paragraph 7 thereof, being the lands owned and claimed by Melvin Reagan and wife, Minnie Reagan, and being a part of Tract NO. 25 of the survey made by the North Carolina Park Commission, at the sum of SIX THOUSAND and 00/100 DOLLARS (\$6,000.00).

(d) That they estimated, appraised and assessed the compensation and damages for the forth tract described in said petition in Paragraph 8 thereof, being the lands owned and claimed by George W. Beck and wife, Cordelia Beck, and being Tracts Nos. 39 and 39a of the survey made by the North Carolina Park Commission, at the sum of FIVE THOUSAND and 00/100 DOLLARS (\$5,000.00).

(e) That they estimated, appraised and assessed the compensation and damages for the fifth tract described in said petition, the same being set out in Paragraph 9 thereof, and being the lands owned and claimed by James Wilson and wife, Lizzie Wilson, and being Tract No. 40 of the survey made by the North Carolina Park Commission, at the sum of THREE THOUSAND, FIVE HUNDRED and 00/100 DOLLARS (\$3,500.00).

(f) That they did not appraise the sixth tract described and referred to in Paragraph 10 of the petition herein, for the reason that the same was withdrawn from their consideration in this proceeding, the owners, M.W. Beck and wife, Julia Beck, having conveyed said tract of land to the petitioner, the State of North Carolina, at a price agreed upon between them.

(g) That they estimated, appraised and assessed the compensation and damages for the seventh tract described in said petition in Paragraph 11 thereof, being the lands owned and claimed by the Heirs at law of J.H. Connor, and being Tract No. 50 of the survey made by the North Carolina Park Commission, at the sum of ELEVEN THOUSAND and 00/100 DOLLARS (\$11,000.00).

(h) That they estimated, appraised and assessed the compensation and damages for the eighth tract described in said petition in Paragraph 12 thereof, being the lands owned and claimed by L.S. Connor and wife, Minnie Connor, and being Tract No. 54 of the

survey made by the North Carolina Park Commission, at the sum of TWO THOUSAND, FIVE HUNDRED and 00/100 DOLLARS (\$2,500.00).

(i) That they estimated, appraised and assessed the compensation and damages for the ninth tract described in said petition in Paragraph 13 thereof, being the lands owned and claimed by J.D. Smith and wife, Emma Smith, and being Tract No. 75 of the survey made by the North Carolina Park Commission and known as the "J.D.S. McMahan Tract," and also Tract No. 73 of the survey made by the North Carolina Park commission and known as the "Ravensford Church Tract," at the sum of EIGHT THOUSAND and 00/100 DOLLARS (\$8,000.00).

That the said commissioners found/NO SPECIAL BENEFITS were assessible against any of said lands.

4. That none of said respondents has filed any exceptions or appeals to said teport within the time allowed by law.

5. That the lands described in the petition lie wholly within the boundaries of the proposed Great Smoky Mountains National Park as defined ~~and described~~ and delimited in the Act of the General Assembly of North Carolina, entitled, "An Act to Provide for the Acquisition of Parks and Recreational Facilities in the Great Smoky Mountains of North Carolina, "ratified on the 25th day of February, 1927, the same being Chapter 48 of the Public Laws of North Carolina, Session of 1927, and particularly in Section 4 of said act, and that all of said lands are embraced within the area of 214,000 acres of land situate in the State of North Carolina designated by the Secretary of the Interior of the United States under authority of the Act of Congress mentioned in the statute aforesaid, namely, Chapter 48, Public Laws of North Carolina, Session of 1927, as properly constituting a portion of the said Great Smoky Mountains National Park, all of which will more particularly appear by reference to said Act of Congress and to said Chapter 48, Public Laws of North Carolina, Session of 1927, aforementioned.

6. That the right eminent domain appertains to and resides in the petitioner as a sovereign state, and that the petitioner has these other and further rights and powers to condemn and appropriate the lands described in the petition for the purposes in said petition mentioned and enumerated under and by virtue of the statute aforementioned.

7. That it is both lawful and necessary for the petitioner to condemn the lands described in the petition for the purposes therein expressed and declared, and that the petitioner is entitled to the relief demanded in the petition:

NOW, THEREFORE, IN THE PREMISES AFORESAID AND UPON MOTION OF COUNSEL FOR THE PETITIONER, IT IS CONSIDERED, ORDERED, ADJUDGED AND DECREED BY THE COURT, as follows:-

#### I.

That the interlocutory judgment and order appointing commissioners in this cause, of date the 31st day of January, 1931, hereinbefore referred to, be, and the same hereby is, in all respects, approved, ratified and confirmed.

#### II.

That the aforementioned report of said commissioners and appraisers, as the same appears in the records and files of this cause, be, and the same hereby is, in all respects, approved, retified and confirmed.

#### III.

That the petitioner forthwith pay into the registry of this Court in full of the compensation which ought justly to be made by the petitioner to the party or parties owning or interested in the lands described in the petition and so appraised by said commissioners and conformable to the report of said commissioners, that is to say:-

(1) For the first tract described in said petition, being Tract No. 11 of the survey made by the North Carolina Park Commission, the sum of TWELVE THOUSAND and 00/100 DOLLARS (\$12,000.00).

(2) For the second tract described in said petition, being Tract No. 24 of the survey made by the North Carolina Park Commission, the sum of EIGHT THOUSAND and 00/100 DOLLARS (\$8,000.00).

(3) For the third tract described in said petition, being part of Tract No. 25 of the survey made by the North Carolina Park Commission, the sum of SIX THOUSAND and 00/100 DOLLARS (\$6,000.00).

(4) For the fourth tract described in said petition, being Tracts Nos. 39 and 39a of the survey made by the North Carolina Park Commission, the sum of FIVE THOUSAND and 00/100 DOLLARS (\$5,000.00).

(5) For the fifth tract described in said petition, being Tract No. 40 of the survey made by the North Carolina Park Commission, the sum of THREE THOUSAND, FIVE HUNDRED and 00/100 DOLLARS (\$3,500.00).

(6) For the seventh tract described in said petition, being Tract No. 50 of the survey made by the North Carolina Park Commission, the sum of ELEVEN THOUSAND and 00/100 DOLLARS (\$11,000.00).

(7) For the eighth tract described in said petition, being Tract No. 54 of the survey made by the North Carolina Park Commission, the sum of TWO THOUSAND, FIVE HUNDRED and 00/100 DOLLARS (\$2,500.00).

(8) For the ninth tract described in said petition, being Tracts Nos. 75 and 73 of the survey made by the North Carolina Park Commission, the sum of EIGHT THOUSAND and 00/100 (\$8,000.00).

The amounts hereinbefore set out represent the amounts for which said several tracts were appraised by said commissioners and the said amounts of money to be paid out and disposed of under the orders of this Court to the party or parties, person or persons entitled thereto, as their interest or interests severally may be made to appear.

#### IV.

That upon the payment into Court by the petitioner of the amounts of money aforesaid, as particularly set forth in the last preceeding section hereto, as hereinbefore and hereby required, the title to all and singular the lands, premises and real estate described in the petition and hereinafter more particularly described, shall, eo instanti, pass to and vest in the petitioner, the State of North Carolina, in fee simple, for the uses and purposes expressed and declared in said petition and in Chapter 48, Public Laws of North Carolina, Session of 1927, free and discharged of and from all adverse claims, liens and encumbrances whatsoever, and the respondents and all other persons whomsoever, as well such person or persons not parties to this proceeding, if any, as the parties hereto, are forever barred from claiming or asserting any manner of estate or interest in said lands, either legal or equitable, whatsoever, the person or persons not parties hereto, having or claiming such estate or interest, if any, being hereby remitted solely to the right of recourse upon the money so paid into Court by the petitioner, and to follow said moneys, or any part thereof, into the hands of any person or persons having the same without good right thereto, as provided by law.

#### V.

That the lands described in the petition, the title to which, through and by virtue of the proceedings had in this cause, becomes vested in the petitioner, the State of North Carolina, are more particularly described as follows:-
