WITNESSETH:

That the said grantors for certain good and valuable considerations moving them thereto, and particularly the sum of **FOUR HUNDRED FIFTY & 00/100----- Dollars (\$ 450.00)**, to them paid by the Grantee the receipt of which is hereby acknowledged, have bargained and sold, and by these presents do hereby bargain, sell and convey unto the said grantee, its successors and assigns, the following described lands in **Ocona Lufty Township, Swain County**, State of North Carolina, particularly described as follows, viz:

Being State Grant No. 978

REGINNING at corner one, a beach stump, shown by J.C. Reagon as being the beginning corner of Grant No. 978, a 6" buckeye blazed and scribed B.T. F. I bears N. 75-00 W. 35 chains distance; thence with the line of Grant No. 978, N. 5-56 W. 7.40 chains to corner 2, a post in a flat, scribed FII, an 8" chestnut, blazed and scribed B.T. F. II bears S. 54-00 E. 30 chains distance; thence N. 27-51 W. 9.52 chains to corner 3, a post scribed F-III, with two doffwood witnesses; thence N. 87-36 W. 19.21 chains to corner 4, a post, on a slope, an 8" chestnut, blazed and scribed B.T.F.- IV 4, bears S. 62-00 W. 18 distance; thence S. 2-18 W. 15.35 chains to locust post, in a small hallow, scribed F-5; thence S. 87-00 E. 25.03 chains to the place of beginning. Containing 35.47 acres.
