BEGINNING At corner 1, which is corner 4 of the Walter Beck Tract (102), a planted stone; thence, with two lines of the J.W. Wilson Tract (32), N. 67-33 W., 2.70 chains, Corner 2, a stake; S. 49-46 W., 5.10 chains, Corner 3, which is Corner 8 of the Tom Beck Tract (108); thence, with two lines of the Tom Beck Tract (108), S. 68-22 E., 3.03 chains, Corner 4, a planted stone; N. 50-12 E., 5.10 chains. Corner 5, a point in line of the Walter Beck Tract (102); thence, N. 69-15 W., .36 chains, the place of BEGINNING, containing 1.33 acres.
