THIS DEED, Made this 12th day of October, A.D. 1929, by and between Tom Beck and wife, Addie Beck of Swain County, North Carolina, hereinafter called GRANTORS, whether one or more, and THE STATE OF NORTH CAROLINA, hereinafter called GRANTEE:

WITNESSETH:

That the said grantors for certain good and valuable considerations moving them thereto, and particularly the sum of FOUR HUNDRED FIFTY Dollars (\$ 450.00), to them paid by the Grantee the receipt of which is hereby acknowledged, have bargained and sold, and by these presents do hereby bargain, sell and convey unto the said grantee, its successors and assigns, the following described lands in Ocona Lufty Township, Swain County, State of North Carolina, particularly described as follows, viz.: TRACT NO. 108.

NOTE: All bearing s in this description were turned from the true meridian and all distances are expressed in chains of 66 feet.  
Lying on the West side of Ocona Lufty River, a short distance below Smokemont.  
BEGINNING at corner 1, which is corner B of the Walter Beck Tract (102), an 18" sycamore, scribed W. B. Cor. II; thence South 5-33 West 4.24 chains, corner 2, a stake; thence South 61-30 West 3.60 chains, corner 3, a stake scribed T. B. Cor. III; thence South 60-15 West 9.84 chains, corner 4, a stake scribed T.B. Cor IV, a 5" dogwood, scribed B.T.T.B. Cor. IV, marked as a witness; thence, North 42-00 West 3.46 chains, corner 5, a fence post scribed T.B. Cor.V; thence, North 34-29 East 1.37 chains, corner 6, a 5" maple scribed T.B. Cor. VI; thence, North 26-00 West 4.60 chains, corner 7, a fence post scribed T.B. Cor. VII; thence North 49-00 East 5.05 chains, corner 8, which is corner 3 of the Pete Mathis Tract (101); thence South 68-22 East 3.03 chains corner 9, a planted stone; thence North 50-12 East 5.10 chains, corner 10, a point in the line of the Walter Beck Tract (102); thence South 69-15 East 5.85 chains, corner 11, a stake scribed W.B. Cor. III; thence South 8-56 West .65 chains, the place of beginning, containing 12.17 acres.

Also all other pieces, parcels or lots of land or interest in lands located within the area designated by the Secretary of the Interior as the "Great Smoky Mountains National Park".

TO HAVE AND TO HOLD the said premises, above described, with every privilege and appurtenance thereunto belonging, to the said grantee, its successors and assigns, to its and their only use and behoof forever.

The grantors covenant to and with the grantee, its successors and assigns: That they are the owners of and are seized of the premises in fee; that they have good right to convey the same in fee simple; that the said premises are free and clear from encumbrances, except as hereinafter stated; and, that they will forever warrant and defend their said title to said premises against the claims of any and all persons whatsoever.
