THIS DEED, Made this 14 day of August, A.D. 1929, by and between William Springer and wife Larcenie Springer of Swain County, North Carolina, hereinafter called GRANTORS, whether one or more, and THE STATE OF NORTH CAROLINA, hereinafter called GRANTEE:

WITNESSETH:

That the said grantors for certain good and valuable considerations moving them thereto, and particularly the sum of TWO Thousand Five Hundred Dollars Dollars (\$ 2500.00), to them paid by the Grantee the receipt of

which is hereby acknowledged, have bargained and sold, and by these presents do hereby bargain, sell and convey unto the said grantee, its successors and assigns, the following described lands in Charleston Township, Swain County, State of North

Carolina, particularly described as follows, viz: TRACT (112).

NOTE: All bearings in this description were turned from the true meridian and all distances are expressed in chains of 66 feet. Lying on both sides of Cooper's Creek and about one and a quarter miles from its source, being exception No. 1 to the Champion Fibre Company Tract (1), BEGINNING at corner 1, a 34" chestnut with old markings, blazed and scribed S-1, .50 chain north of a branch; thence, N. 30-25 E. 12.14 chains, small stream flows southeast 26.46 chains small stream flows southeast, 35-40 chains small stream flows southeast, 42-74 chains corner 2, an 18" pine with old markings, blazed and scribed S-2, on south slope; thence, S. 25-11 E. 16.52 chains, Cooper's Creek South 24.40 chains. Corner 3, a chest. stump with witnesses, stump blazed and scribed S-3. A 16" spanish oak blazed and scribed B. T. S-3, bears S. 50-00 E. 15 chain distant; thence S. 30-29 W. 6.68 chains small stream flowing West 41.52 chains small spring S. 75-00 W. 42.85 chains. Corner 4, a large poplar stump with witnesses, blazed and scribed S-4, A 10" red oak blazed and scribed B. T. S. 4, bears N. 13-00 W. 10 chain distant; thence N. 25-25 W. 2.50 chains a small stream flowing S. 60-00 West 13.56 chains Cooper's Creek flowing South 24.44 chains the place of BEGINNING, containing 81.39 acres.

TRACT (112-a)

Lying about one-fourth mile East of Cooper's Creek, at a point about two miles from its source. BEGINNING at Corner 1, a point at intersection of ridge top with a painted line set a sassafrass post scribed C. F. A 10" hickory scribed B. T. C. F. bears North .40 chain distant Corner 49, of the Champion Fibre Co. Tract (1); thence with the Champion Fibre Co. Tract (1) S. 66-54 W. 39.01 chains. Corner 2, a planted stone with witnesses on top of a ridge. Corner 50 of the Champion Fibre Company Tract (1); thence with the ridge top S. 41-02 E. 6.38 chains corner 3 a point with witnesses on a high knob set a post scribed C. F. Corner 1, of the Champion Fibre Co. Tract (1h); thence with the Champion Fibre Co. Tract (1h) N. 81-17 E. 24.97 chains corner 4, a small planted stone with witnesses on top of dividing ridge, a 24" black oak, blazed and scribed B.T.C.F. bears North .35 chain distant; thence N. 23-14 E. 17.78 chains the place of BEGINNING, containing 30.67 acres.

Also all other pieces, parcels or lots of land or interests in lands located within the area designated by the Secretary of the Interior as the "Great Smoky Mountains National Park".

TO HAVE AND TO HOLD the said premises, above described, with every privilege and appurtenance thereunto belonging, to the said grantee, its successors and assigns, to its and their only use and behoof forever.

The grantors covenant to and with the grantee, its successors and assigns: That they are the owners of and are seized of the premises in fee; that they have good right to convey the same in fee simple; that the said premises are free and clear from encumbrances, except as hereinafter stated; and, that they will forever warrant and defend their said title to said premises against the claims of any and all persons whatsoever.
