of Swain County, North Carolina, hereinafter called GRANTORS, whether one or more, and THE STATE OF NORTH CAROLINA, hereinafter called GRANTEE:

WITNESSETH:

That the said grantors for certain good and valuable considerations moving them thereto, and particularly the sum of **FOUR HUNDRED** Dollars (\$ 400.00), to them paid by the Grantee the receipt of which is hereby acknowledged, have bargained and sold, and by these presents do hereby bargain, sell and convey unto the said grantee, its successors and assigns, the following described lands in Charleston Township, Swain County, State of North Carolina, particularly described as follows, viz.: **TRACT NO. 115:**

NOTE: All bearings in this description were turned from the true meridian and all distances are expressed in chains of 66 feet.

Lying on the East bank of Indian Creek and the North bank of George's Branch; BEGINNING at corner 1, a planted stone with witnesses on North side of George's Branch, a common corner of Allen Bumgarner tract (114); thence North 2-06 East 40.30 chains, to corner 2, a point with witnesses .20 chain North of a small Branch, set a chestnut post scribed J. S. Cor. 2, a 30" chestnut, blazed and scribed B.T.J.S. Cor.2, bears North 32-00 East .20 chain distant; thence North 88-34 West 4.58 chains, corner 3, a point on the East Bank of Indian Creek and corner 1 of the J. F. Shuler Tract (116); thence, with the Shuler Tract (116), and the meanders of Indian Creek South 4-49 East 2.61 chains; South 23-57 West 3.56 chains; South 9-47 West 3.67 chains; South 47-28 East 4.30 chains; South 19-55 West 3.82 chains; South 37-43 West 3.02 chains; South 5-32 East 1.45 chains; South 8-43 East 2.16 chains; South 11-41 West 2.73 chains; South 7-21 East 11.13 chains; South 31-14 West 2.94 chains; South 41-15 West 2.83 chains, ~~near~~ corner 4, a point on the East bank of Indian Creek, corner 4 of the Shuler Tract (116), and a point in the line of the Champion Fibre Co. Tract (1), Exception 4; thence ~~with~~ the Champion Fibre Co. Tract (1), exception 4 South 86-54 East 1.13 chains, corner 5, a point on the North side of George's Branch and a common Corner to the Allen Bumgarner Tract (114); thence with the Bumgarner Tract (114) South 88-13 East 5.27 chains, the place of beginning, containing 19.07 acres.

TO HAVE AND TO HOLD the said premises, above described, with every privilege and appurtenance thereunto belonging, to the said grantee, its successors and assigns, to its and their only use and behoof forever.

The grantors covenant to and with the grantee, its successors and assigns: That they are the owners of and are seized of the premises in fee; that they have good right to convey the same in fee simple; that the said premises are free and clear from encumbrances, except as hereinafter stated; and, that they will forever warrant and defend their said title to said premises against the claims of any and all persons whatsoever.
