THIS DEED, Made this 23rd day of February, A.D. 1929, by and between  
J. E. Shuler and wife, Nora  
of Swain County, North Carolina, hereinafter called GRANTORS, whether one or more, and THE STATE OF NORTH CAROLINA, hereinafter called GRANTEE:

## WITNESSETH:

That the said grantors for certain good and valuable considerations moving them thereto, and particularly the sum of One Thousand Five Hundred Fifty----- Dollars (\$1,550.00), to them paid by the Grantee the receipt of which is hereby acknowledged, have bargained and sold, and by these presents do hereby bargain, sell and convey unto the said grantee, its successors and assigns, the following described lands in Township, Swain County, State of North

Carolina, particularly described as follows, viz: Tract No. 116

NOTE : All bearings in this description were turned from a true meridian and all distances are expressed in chains of 66 feet.

Lying on the West bank of Indian Creek and just above the mouth of George's Branch.

Beginning at Corner 1, a point on the east bank of Indian Creek, corner 3 of the Ed Stiles Tract (115), and in the line of the Champion Fibre Co. Tract (1) exception 4 North 88-34 West 20.34 chains, Corner 2, a chestnut post, old corner with witnesses, a 16" chestnut blazed and scribed R.T.J.S.Cor. 4, bears North 52-00 East .09 chain distant South 2-17 West 39.91 chains, corner 3, a point with witnesses, set a chestnut post scribed J.S.Cor. 5, a 12" chestnut blazed and scribed B.T.J.S. Cor. 5, bears North 22-00 West .15 chain distant; South 86-54 East 18.34 chains, Corner 4, a point on the east bank of Indian Creek and corner 4 of the Ed Stiles Tract (115) thence, with the Stiles Tract (115), and the meanders of the branch North 41-15 East 2.83 chains; North 31-14 East 2.94 chains; North 7-21 West 11.13 chains; North 11-41 East 2.73 chains; North 8-43 West 2.16 chains; North 5-32 West 1.45 chains; North 37-43 East 3.02 chains; North 19-55 East 3.82 chains; North 47-28 West 4.30 chains; North 9-47 East 3.67 chains; North 23-57 East 3.56 chains; North 4-49 West 2.61 chains, the place of beginning, containing 80.62 acres.

Also all other pieces, parcels or lots of land or interest in lands located within the area designated by the Secretary of the Interior as the "Great Smoky Mountains National Park".

TO HAVE AND TO HOLD the said premises, above described, with every privilege and appurtenance thereunto belonging, to the said grantee, its successors and assigns, to its and their only use and behoof forever.

The grantors covenant to and with the grantee, its successors and assigns: That they are the owners of and are seized of the premises in fee; that they have good right to convey the same in fee simple; that the said premises are free and clear from encumbrances, except as hereinafter stated; and, that they will forever warrant and defend their said title to said premises against the claims of any and all persons whatsoever.
