THIS DEED, Made this 28th day of May, A.D. 1929, by and between W.M. Laney and wife N.M. Laney of Swain County, North Carolina, hereinafter called GRANTORS, whether one or more, and THE STATE OF NORTH CAROLINA, hereinafter called GRANTEE:

WITNESSETH:

That the said grantors for certain good and valuable considerations moving them thereto, and particularly the sum of One Thousand and six Hundred Dollars (\$ 1600.00), to them paid by the Grantee the receipt of which is hereby acknowledged, have bargained and sold, and by these presents do hereby bargain, sell and convey unto the said grantee, its successors and assigns, the following described lands in Charleston Township, Swain County, State of North Carolina, particularly described as follows, viz:

Tract No. 117:

NOTE: All bearings in this description were turned from the true meridian, and all distances are expressed in chains of 66 feet.

Lying on Indian Creek, and being part of Exception 4, to the Champion Fibre Co. Tract (1):

BEGINNING at Corner 1, which is corner 2 of Exception 4 to the Champion Fibre Co. Tract(1), and corner 2 of the W.R. Stiles Tract(118 -a), a point with witnesses, on a ridge, and in the East boundary of the original Laney Tract; thence North 40-52 East 3-25 chains a stream flows northwest, 35-99 chains, Corner 2, a locust post, with witnesses, scribed W.L. Cor. 4, a 14" chestnut oak, blazed and scribed B.T.W.L. Cor. 4, bears N. 24-00 E..06 chain distant; thence North 51-58 West 15.65 chains, Corner 3, a white oak stump, corner 3 of the Allen Bumgarner Tract (114); thence North 77-18 West with a line of the Allen Baumgarner Tract (114), 14 30 chains, Corner 4, which is corner 1 of the J.E. Coburn Tract (100-b), a point on East bank of Indian Creek, in the North boundary of the original Laney Tract, set a post, athree pronged white walnut, blazed and scribed B.T.A.B. Cor. 3, bears South 40-00 West .15 chain distant; thence, down Indian Creek, with it meanders South 22-49 West 1.74 chains; South 3-00 East 1.68 chains; South 30-57 West 3.03 chains; South 5-41 West 1.60 chains; South 24-49 West 5.35 chains; South 3-44 West 2.12 chains; South 7-00 West 3.09 chains, corner 5, apoint at the mouth of Stiles Branch; thence, up Stiles Branch with its meanders North 73-26 West 1.87 chains; North 57-15 West 2.25 chains; South 68-43 West 1.69 chains, corner 6, which is Corner 3 of the J.E. Coburn Tract (100-b), a post beside a 6" basewood, blazed and seribed J.C. Cor. 3, in Stiles Branch; thence , South 13-39 West 22.46 chains, Corner 7, a 14" white oak, with old marks and witnesses, scribed W.L. Cor 2; thence South 76-13 East 5.84 chains, Corner 8, a stake on the bank of Indian Creek, scribed R.S. Cor. 1, W.L. Cor. 3; thence, up Indian Creek, with it meanders North 26-15 East 2.98 chains; North 20-20 East 5.16 chains ; North 19-01 East 4.00 chains, Corner 9, a20" chestnut, scribed R.S. Cor. 3; thence, South 62-00 East 13.79 chains, the place of beginning, containing 97. 83 acres.

Also all other peices, parcels or lots of land or interest in lands located within the area designated by the Secretary of the Interior as the "Great Smokey Mountains National Park."

TO HAVE AND TO HOLD the said premises, above described, with every privilege and appurtenance thereunto belonging, to the said grantee, its successors and assigns, to its and their only use and behoof forever.

The grantors covenant to and with the grantee, its successors and assigns: That they are the owners of and are seized of the premises in fee; that they have good right to convey the same in fee simple; that the said premises are free and clear from encumbrances, except as hereinafter stated; and, that they will forever warrant and defend their said title to said premises against the claims of any and all persons whatsoever.
