WITNESSETH:

That the said grantors for certain good and valuable considerations moving them thereto, and particularly the sum of -----
Two Thousand ----- Dollars (\$ 2,000.00), to them paid by the Grantee the receipt of
which is hereby acknowledged, have bargained and sold, and by these presents do hereby bargain, sell and convey unto the said grantee, its successors
and assigns, the following described lands in Charleston Township, Swain County, State of North
Carolina, particularly described as follows, viz.: Tracts Nos. 118, 118a.

Note. All bearings in this description were turned from the true meridian and all distances
distances are expressed in chains of 66 feet.

Lying on the waters of Indian Creek, about 30 chains West of the mouth of George's Branch,
being exception #51 of Champion Fibre Company Tract No. 1.

BEGINNING at Corner 1, a chestnut stump, the Southeast corner, Thence N. 89-10 W. 24.48
Chains Corner 2, a post scribed W. S. Cor. 2; thence N. 1-53 E. 20.39 Chains to Corner
3, a point with witnesses, set Locust Post, scribed W. S. Cor. 3; thence S. 85-51 E.
25.17 Chains to Corner 4, a 20" Chestnut blazed and scribed B.T.W.S. 2, Cor. 4, bears
N. 3-00 E. .06 Chains distant; thence S. 2-21 W. 20.23 Chains to the place of Beginning.
