THIS DEED, Made this 8th Kitchen day of March, A.D. 1930, by and between J.C. Kitchen, wife,
of YORK County, North Carolina, hereinafter called GRANTORS, whether one or more, and THE STATE OF NORTH CARO-
LINA, hereinafter called GRANTEE:

WITNESSETH:

That the said grantors for certain good and valuable considerations moving them thereto, and particularly the sum of FOURTEEN HUNDRED 2 Dollars (\$ 1400.00), to them paid by the Grantee the receipt of which is hereby acknowledged, have bargained and sold, and by these presents do hereby bargain, sell and convey unto the said grantee, its successors and assigns, the following described lands in Swain Township, Swain County, State of North Carolina, particularly described as follows, viz:

TRACT NO 123:

NOTE: All bearings in this description were turned from the true meridian and all distance are expressed in chains of 66 feet.

Lying on the West Bank of Indian Creek, about three-fourth of a mile from its mouth.

BEGINNING at corner 1, a 38" chestnut scribed C.K. Cor. 1 on west bank of creek; thence North 74-57 West 28.85 chains, corner 2, an 18" white oak with witnesses, scribed C.K. Cor. 2; thence ~~South~~ 7-09 West 27-33 chains, corner 3, a 10" sourwood with old markings and witnesses, on top of a ridge, corner 3 of the Blanton Tract (124); thence with the Blanton Tract (124), and the meanders of the ridge South 2-24 East 2.68 chains; South 32-24 West 1.05 chains; South 7-16 West 1.90 chains; South 15-05 East 2.42 chains; South 34-10 East 2.14 chains; South 17-58 East 2.17 chains; South 4-47 East 3.50 chains, corner 4, a point on a ridge, set a post scribed B- chestnut witnesses, corner 2 of the A.T. Blanton Tract (124); thence North 60-52 East 5-84 chains, corner 5, a 10" chestnut stump on North bank of Indian Creek, set a post scribed C.K. Cor. 4; thence up Indian Creek with its meanders North 41-00 East 10.23 chains; North 14-00 East 1.86 chains; North 51-00 East 3.22 chains; North 27-00 East 3-09 chains; North 0-47 East 1.51 chains; North 24-30 East 5.05 chains; North 75-57 East 4.05 chains; North 44-14 East 2.98 chains; North 85-29 East 1.08 chains; North 23-12 East 1.81 chains; North 69-23 East 3.23 chains; North 15-47 East 6.55 chains, the place of BEGINNING, containing 71.57 acres.

EXCEPTION NO. 1:

Being the Indian Creek school tract. BEGINNING at a point in the center line of Indian Creek, South 15-47 West 3-00 chains from corner 1 of the Columbus Kitchen tract; thence North 71-05 West 1.93 chains, a chestnut 10 feet north of a spring; thence South 42-13 West 4.04 chains; thence South 58-00 West 5.95 chains, a poplar with corner marks; thence South 8-43 East 3.30 chains, a point in the center line of Indian Creek; thence up Indian Creek with its meanders North 75-57 East 1.09 chains; North 44-14 East 2.98 chains; North 85-29 East 1.08 chains; North 23-12 East 1.81 chains; North 69-23 East 3.23 chains; North 15-47 East 3.55 chains, the place of beginning, containing 3.20 acres.

EXCEPTION NO. 2:

Being the Indian Creek Cemetery, BEGINNING at a stake which lies North 35-18 West .39 chain from the third corner of Exception 1; thence North 86-42 West .99 chains; thence North 9-59 West 1.52 chains; thence North 68-02 East 1.20 chains; thence South 4-44 East 2.02 chains, the place of BEGINNING, containing .19 acres.

EXCEPTION NO. 3:

Being the Indian Creek Church tract. BEGINNING at corner 1 of the Columbus Kitchen Tract, a 38" chestnut scribed C.K. Cor. 1, on west bank of Indian Creek; thence North 74-57 West 2.72 chains, a chestnut stake scribed C-Cor. 2; thence South 50-36 West 3.27 chains, on oak stake scribed C. Cor. 3; thence South 71-05 E. 2.61 chains, a chestnut, the second corner of exception No. 1 4.54 chains, a point in the center of Indian Creek, the beginning corner of exception No. 1; thence North 15-47 East 3.00 chains, the place of beginning, containing 1.08 acres.

Also all other piece, parcels or lots of land or interest in lands located within the area designated by the Secretary of the Interior as the Great Smoky Mountains National Park.

TO HAVE AND TO HOLD the said premises, above described, with every privilege and appurtenance thereunto belonging, to the said grantee, its successors and assigns, to its and their only use and behoof forever.

The grantors covenant to and with the grantee, its successors and assigns: That they are the owners of and are seized of the premises in fee; that they have good right to convey the same in fee simple; that the said premises are free and clear from encumbrances, except as hereinafter stated; and, that they will forever warrant and defend their said title to said premises against the claims of any and all persons whatsoever.
