THIS DEED, Made this 10th day of September, A.D. 19 29 by and between
Ed. Shuler and wife, Mollie Shuler,
of Swain County, North Carolina, hereinafter called GRANTORS, whether one or more, and THE STATE OF NORTH CAROLINA, hereinafter called GRANTEE:

WITNESSETH:

That the said grantors for certain good and valuable considerations moving them thereto, and particularly the sum of FOUR HUNDRED FIFTY Dollars (\$ 450.00), to them paid by the Grantee the receipt of

which is hereby acknowledged, have bargained and sold, and by these presents do hereby bargain, sell and convey unto the said grantee, its successors and assigns, the following described lands in Charleston Township, Swain County, State of North

Carolina, particularly described as follows, viz.: T.R.A.C.T. N.O. 127

NOTE: All bearings in this description were turned from the true meridian and all distances are expressed in chains of 66 feet.

BEGINNING at corner 1, a locust stump on the east bank of Deep Creek, at the point of a ridge; thence up the ridge, with its meanders N. 34-24 East 3.96 chains; North 53-55 East 4.41 chains; North 52-04 E. 4.21 chains; North 77-09 East 3.45 chains, corner 2, a point on ridge top, with a white oak witness, at intersection with a line of the Champion Fibre Co. Tract (1); thence, with three lines of the Champion Fibre Company Tract (1) South 68-45 East 5.82 chains, small stream flows South 40-00 West 15-32 chains, corner 3, a locust post with witnesses, a 16" chestnut, blazed and scribed B.T.S-3, bears North .23 chain distant South 2-52 West 10.06 chains, corner 4, a locust post with witnesses, a 12" white oak, blazed and scribed B.T.S-2, bears North 3-00 West .20 chain distant North 86-38 West 3.72 chains, corner 5, a locust post with witnesses, a 16" black oak, blazed and scribed B.T.J-2, bears North 10-00 West 15 chain distant South 89-43 West with a line of the George Jenkins Tract (126) 10.16 chains, corner 6, the S.E. corner of the Will Jenkins Tract (125-a) an oak with corner marks; thence with two lines of the Will Jenkins Tract (125-a) North 26-57 West 5.46 chains, corner 7, a walnut with corner marks, near a small stream South 54-52 West 5.32 chains, corner 8, a walnut marked as a corner, on the bank of Deep Creek; thence, up Deep Creek with its meanders North 65-14 West 4.98 chains; North 26-05 West 2.53 chains, the place of beginning, containing 29.03 acres.

Also all other pieces, parcels or lots of land or interest in lands located within the area designated by the Secretary of the Interior as the "Great Smoky Mountains National Park".

TO HAVE AND TO HOLD the said premises, above described, with every privilege and appurtenance thereunto belonging, to the said grantee, its successors and assigns, to its and their only use and behoof forever.

The grantors covenant to and with the grantee, its successors and assigns: That they are the owners of and are seized of the premises in fee; that they have good right to convey the same in fee simple; that the said premises are free and clear from encumbrances, except as hereinafter stated; and, that they will forever warrant and defend their said title to said premises against the claims of any and all persons whatsoever.
