THIS DEED, Made this 25th day of March, A.D. 19 28 and between John Carver and wife,
Nippie

of Swain County, North Carolina, hereinafter called GRANTORS, whether one or more, and THE STATE OF NORTH CAROLINA, hereinafter called GRANTEE:

WITNESSETH:

That the said grantors for certain good and valuable considerations moving them thereto, and particularly the sum of Three hundred fifty ----- Dollars (\$ 350.00), to them paid by the Grantee the receipt of which is hereby acknowledged, have bargained and sold, and by these presents do hereby bargain, sell and convey unto the said grantee, its successors and assigns, the following described lands in Ocona Lufty Township, Swain County, State of North Carolina, particularly described as follows, viz.:

Tract No. 13:

NOTE: All bearings in ~~XXXXXX~~ this description were turned from the true meridian and all distances are expressed in chains of 66 feet.

Lying on the waters of Bradley Fork of Ocona Lufty River. Beginning at Corner 1, which is corner 1 of the Julius Carver Tract (9), and corner 2 of the A.A. Carver Tract (8), a point in middle of Bradley Fork; thence, with two lines of the Julius Carver Tract (9), South 72-09 West 3.42 chains, corner 2, a birch stump near a spring North 41.07 West 3.59 chains, corner 3, a planted stone beside a poplar stump, a corner of the William Gibson Tract; thence, with the William Gibson Tract North 40-48 East 4.73 chains, corner 4, a post at corner of fence North 59-41 East 1.38 chains; corner 5, a sycamore stump on the west bank of the river; thence, with the meanders of the river South 12-43 6.08 chains, the place of beginning, containing 2.23 acres.

Also all other pieces, parcels or lots of land or interests in lands located within the area designated by the Secretary of the Interior as the "Great Smokey Mountains National Park."

TO HAVE AND TO HOLD the said premises, above described, with every privilege and appurtenance thereunto belonging, to the said grantee, its successors and assigns, to its and their only use and behoof forever. The grantors covenant to and with the grantee, its successors and assigns: That they are the owners of and are seized of the premises in fee; that they have good right to convey the same in fee simple; that the said premises are free and clear from encumbrances, except as hereinafter stated; and, that they will forever warrant and defend their said title to said premises against the claims of any and all persons whatsoever.
