## WITNESSETH:

That the said grantors for certain good and valuable considerations moving them thereto, and particularly the sum of TWELVE HUNDRED FIFTY Dollars (\$ 1250.00), to them paid by the Grantee the receipt of which is hereby acknowledged, have bargained and sold, and by these presents do hereby bargain, sell and convey unto the said grantee, its successors and assigns, the following described lands in

Township,

County, State of North

Carolina, particularly described as follows, viz: T. R. A. C. T. N. O. 1 3 1;

Lying about half way between Noland and Mill Creeks, approximately one and a ~~quarter~~ miles above their junction and being Exception No. 9 to the Champion Fibre Co. Tract (1).

BEGINNING at corner 1; thence North 28-37 East 31.42 chains, corner 2; thence North 60-09 West 16.06 chains, corner 3; thence South 30-42 West 31.46 chains, corner 4; thence South 60-35 East 17.24 chains, the place of BEGINNING, containing 52.34 acres.

Also all other pieces, parcels or lots of land or interest in lands located within the area designated by the Secretary of the Interior as the "Great Smoky Mountains National Park".

TO HAVE AND TO HOLD the said premises, above described, with every privilege and appurtenance thereunto belonging, to the said grantee, its successors and assigns, to its and their only use and behoof forever.

The grantors covenant to and with the grantee, its successors and assigns: That they are the owners of and are seized of the premises in fee; that they have good right to convey the same in fee simple; that the said premises are free and clear from encumbrances, except as hereinafter stated; and, that they will forever warrant and defend their said title to said premises against the claims of any and all persons whatsoever.
