T H I S I N D E N T U R E, Made this April _____, 1932, by and between JAMES G. K. McCLURE, JR., of Buncombe County, North Carolina, Receiver of North State Corporation, party of the first part, and the STATE OF NORTH CAROLINA, party of the second part,

W I T N E S S E T H :

WHEREAS, the party of the first part by an order of the Superior Court of Buncombe County, North Carolina, entered on April 19th, 1932, in a civil action therein pending entitled "R. Douglas Stuart vs. North State Corporation", was directed as Receiver of said Corporation under an appointment heretofore made by said Court in said case, to sell to the North Carolina Park Commission a tract of land hereinafter described, and on receipt of an acknowledgment of payment in full of an indebtedness of said North State Corporation to said Park Commission to convey said tract of land to said Commission or to such grantee as it might designate; and

Whereas, evidence of the payment of said obligation above referred to has been delivered to the party of the first part, and said Commission has directed the execution of said deed of conveyance to the party of the second part hereto;

NOW THEREFORE, said party of the first part, for and in consideration of the premises, and of other valuable considerations, the receipt of which is hereby acknowledged, has bargained and sold, and does hereby bargain, sell and convey unto the said party of the second part, its successors and assigns, the following described tract of land in Swain County, North Carolina, bounded and described as follows:

Lying West of the divide between Mill Creek and Noland Creek, and along the road up Mill Creek.

W I T N E S S E T H:

That said T.P.Siler Admr. and T.P.Siler and his wife Jane, for and in consideration of One Hundred Dollars to them in hand paid by J.J.McCoy, the receipt of which is hereby acknowledged have bargained and sold, and by these presents do bargain, sell and convey to said J.J.
