WITNESSETH:

That the said grantors for certain good and valuable considerations moving them thereto, and particularly the sum of Seven hundred Fifty Dollars (\$ 750.00), to them paid by the Grantee the receipt of which is hereby acknowledged, have bargained and sold, and by these presents do hereby bargain, sell and convey unto the said grantee, its successors and assigns, the following described lands in Forney Creek Township, Swain County, State of North Carolina, particularly described as follows, viz.:

Note All bearings in this description were turned from the true meridian, and all distances are expressed in chains of 66 feet.

Lying on both sides of Noland Creek, about 1½ miles above the mouth of Mill Creek. Beginning at corner 1, which is corner 127 of the Champion Fibre Co. Tract (1) a chestnut with old marks;

Thence E. 11-36 E.

With a line of the James Laws Tract (137) corner 2, which is corner 121 of the Champion Fibre Co Tract (1) a 6" chestnut with old markings, scribed J.N. Laws Corner2;

Thence N. 83-42 E.

With line of the Champion Fibre Co. Tract (1) Corner 3, a " sourwood, scribed C.L. Cor. 1.W.K. Cor.1;

Thence N.14-02 W.

With a line of the J.K. McClure tract (135) corner 4, which is corner 125 of the Champion Fibre Co. Tract (1) a chestnut post scribed C.L. Cor.2 W.K.M. Cor. 2;

Thence S. 80-52 W. with a line of the Champion Fibre Co. Tract (1) The place of beginning, containing 24.16 acres

Also all others pieces, parcels or lots of land or interest in land located within the area designated by the Secretary of the Interior as the "Great Smoky Mountains National Park".

TO HAVE AND TO HOLD the said premises, above described, with every privilege and appurtenance thereunto belonging, to the said grantee, its successors and assigns, to its and their only use and behoof forever.

The grantors covenant to and with the grantee, its successors and assigns: That they are the owners of and are seized of the premises in fee; that they have good right to convey the same in fee simple; that the said premises are free and clear from encumbrances, except as hereinafter stated; and, that they will forever warrant and defend their said title to said premises against the claims of any and all persons whatsoever.
