THIS DEED, Made this 23rd day of May, A.D. 19 9 , by and between Ben Lollis and wife Martha Lollis

of Swain County, North Carolina, hereinafter called GRANTORS, whether one or more, and THE STATE OF NORTH CAROLINA, hereinafter called GRANTEE:

WITNESSETH:

That the said grantors for certain good and valuable considerations moving them thereto, and particularly the sum of One Thousand Eight Hundrad Dollars (\$ 1800.00), to them paid by the Grantee the receipt of which is hereby acknowledged, have bargained and sold, and by these presents do hereby bargain, sell and convey unto the said grantee, its successors and assigns, the following described lands in Charleston Township, Swain County, State of North Carolina, particularly described as follows, viz.:

NOTE: All bearings in this description were turned from the true meridian and all distances are expressed in chains of 66 feet.

BEGINNING at corner 1, which is corner 104 of the Champion Fibre Company Tract (1), and corner 25 of the A.T. Lollis Tract (146) a 6" black gum with old markings and witness, blazed and scribed C.F. A 6" pine blazed and scribed B.T.C.F. bears S. 81-00 W. 2.20 chain distant; Thence, with lines of the A.T. Lollis Tract (146) South 62-38 E. 2.50 chains Corner 2, a chestnut post N. 56-51 E. 2.42 chains Corner 3, a post S. 61-54 E. 5.41 chains Corner 4, which is corner 1 of the Lee Wiggins Tract (145), an 8" white oak with mark and paint; Thence, with lines of the Lee Wiggins Tract (145) N. 5-04 W. 2.61 chains Corner 5, a chestnut oak stump with sourwood witness, in edge of field N. 47-08 W. 5.73 chains Corner 6, a 22" hickory with old marks, on east slope N. 54-51 E. 13.80 chains Corner 7, a post oak stump with pine and red oak witnesses, on ridge top shown by Ben Lollis as site of corner; Thence up the ridge with its meanders N. 33-16 W. 3.99 chains N. 13-05 E. 6.23 chains N. 2-20 W. 2.65 chains N. 29-37 E. 3.31 chains N. 20-56 E. 4.56 chains N. 14-50 E. 2.54 chains Corner 8, a white oak with marks on ridge top, in line of the Moses A. Wiggins Tract (142); Thence up the ridge with the Moses A. Wiggins Tract (142) N. 81-14 W. .51 chains N. 42-53 W. 3.20 chains N. 54-22 W. 2.27 chains Corner 9 a post scribed E. 3, which is corner 4 of the Moses A. Wiggins Tract (142), and corner 3 of the Marion Eppey Tract (143), a planted stone with witnesses, A 20" chestnut blazed and scribed B.T. E.-3 bears S. 71-00 W. .12 chains distant. Thence still running with meanders of ridge of the Marion Eppey Tract (143) N. 70-25 W. 3.03 chains N. 46-40 W. 3.12 chains N. 70-00 W. 1.74 chains N. 43-50 W. 1.94 chains N. 20-15 W. 1.55 chains N. 41-26 W. 4.58 chains N. 19-06 W. 1.43 chains Corner 10, which is corner 1 of the Marion Eppey Tract (143), and corner 2 of the Moses A. Wiggins Tract (142) a large black oak with marks, blazed and scribed E-1 A.5" pine blazed and scribed B.T.E.1, bears North .12 chains distant; Thence, with the line of the Moses A. Wiggins Tract (142) N. 32-19 W. 1.32 chains Corner 11, which is corner 99 of the Champion Fibre Co. (1), a 24" chestnut oak with witnesses blazed and scribed C.F. An 18" black oak blazed and scribed B.T.C.F. bears N. 37-00 W. .30 chain distant Thence with lines of the Champion Fibre Co. Tract (1) S. 10-41 W. 9.38 chains Corner 12, a fallen walnut with witnesses. Set a chestnut post scribed C.F. A 6" chestnut blazed and scribed B.T.C.F. bears N. 30-00 E. .07 chain distant S. 73-41 W. 13.00 chains Corner 13, a locust stump at intersection to marked lines scribed C.E. S. 13-58 E. 14.32 chains Corner 14, a cluster of buckeyes marked with red paint, on South bank of small stream S. 10-01 W. 16.79 chains Corner 15, a pine knot at corner of wire fence on ridge top. A 14" white oak blazed and scribed B.T.C.F. bears N. 8-00 E. .35 chain distant Thence, down the ridge with its meanders S. 75-15 E. 2.49 chains S. 69-17 E. 2.01 chains S. 62-37 E. 3.70 chains S. 78-06 E. 1.32 chains S. 58-57 E. 3.59 chains S. 36-48 E. 1.03 chains the place of BEGINNING, containing 97.91 acres.

TO HAVE AND TO HOLD the said premises, above described, with every privilege and appurtenance thereunto belonging, to the said grantee, its successors and assigns, to its and their only use and behoof forever.

The grantors covenant to and with the grantee, its successors and assigns: That they are the owners of and are seized of the premises in fee; that they have good right to convey the same in fee simple; that the said premises are free and clear from encumbrances, except as hereinafter stated; and, that they will forever warrant and defend their said title to said premises against the claims of any and all persons whatsoever.
