THIS DEED, Made this 21st day of September, A.D. 199, by and between
 Hattie McCracken and husband, John McCracken
 of County, North Carolina, hereinafter called GRANTORS, whether one or more, and THE STATE OF NORTH CAROLINA, hereinafter called GRANTEE:

WITNESSETH:

That the said grantors for certain good and valuable considerations moving them thereto, and particularly the sum of ~~50/100~~ ~~\$450.00~~ ~~FOUR HUNDRED~~ Dollars (\$450.00), to them paid by the Grantee the receipt of

which is hereby acknowledged, have bargained and sold, and by these presents do hereby bargain, sell and convey unto the said grantee, its successors and assigns, the following described lands in Township, Swain County, State of North

Carolina, particularly described as follows, viz: TRACTS 154-154-a.

NOTE: All bearings in this description were turned from the true meridian, and all distances are expressed in chains of 66 feet.

BEGINNING, at Corner 1, which is Corner 11 of the A. T. Lollis Tract (146), and Corner 8 of the W. H. Shuler Tract (147), a small dogwood with marks and witnesses. Thence, with lines of the A. T. Lollis Tract (146) N. 41-11 W. 1.09 chains, corner 2, a point with witnesses, S. 31-32 W. 3.36 chains, corner 3, a point with witnesses, in edge of old road and on bank of small stream. S. 9-41 W. with meanders of road. 2.77 chains: S. 31-05 W. 1.62 chains; S. 51-55 W. 1.79 chains; S. 21-06 W. 1.18 chains, corner 4, which is corner 1 of the J. A. Morris Tract (148), a small spanish oak in forks of road; thence, with meanders down the road a line of the J. A. Cathey Tract (157), down a ridge N. 29-52 W. 1.37 chains; N. 22-59 W. 5.23 chains; N. 31-55 W. 2.15 chains; N. 41-31 W. 1.85 chains; N. 47-50 W. 1.96 chains; N. 52-13 W. 2.55 chains, corner 5, a point on lower side of old road, set a chestnut post N. 88-50 E. with old road 2.98 chains; N. 74-21 E. 5.44 chains; N. 54-53 E. 2.72 chains, corner 6, a large white oak stump, shown by Mark Cathey as corner, witnessed by a Persimmon and a hemlock, a corner of the Mark Cathey Tract (158); thence, with a line of the Mark Cathey Tract (158); N. 64-34 W. 1.50 chains, Indian Creek 12.19 chains, corner 7, a chestnut stump with witnesses, in line of the Champion Fibre Company Tract (1); thence, with a line of the Champion Fibre Co. Tract (1) S. 66-23 W. 6.40 chains, corner 8, which is a corner of the Town of Bryson Tract (156), a point in the Champion Fibre Co. line; thence, with lines of the Town of Bryson Tract (156), S. 83-35 E. 1.01 chains, a point in Indian Creek 1.50 chains from its mouth; S. 11-57 E. 1.60 chains, a point on west bank of road; S. 47-59 E. 1.99 chains, a point on west bank of road; S. 48-16 E. 3.15 chains; S. 11-34 E. 2.80 chains; S. 4-19 E. 1.65 chains; S. 21-46 W. 2.44 chains; S. 17-31 W. 2.20 chains; S. 58-52 W. 3.25 chains; S. 68-28 W. 3.36 chains, corner 9, a rock on bank of road; thence, S. 3-59 W. leaving road and still running with the Town of Bryson Tract (156) 4.20 chains to the place of BEGINNING, containing 25.03 acres.

The grantors covenant to and with the grantee, its successors and assigns: That they are the owners of and are seized of the premises in fee; that they have good right to convey the same in fee simple; that the said premises are free and clear from encumbrances, except as hereinafter stated; and, that they will forever warrant and defend their said title to said premises against the claims of any and all persons whatsoever.
