THIS DEED, Made this 28th day of October, A.D. 1930, by and between
The Town of Bryson City, a municipal Corporation
of Swain County, North Carolina, hereinafter called GRANTORS, whether one or more, and THE STATE OF NORTH CAROLINA, hereinafter called GRANTEE:

WITNESSETH:

That the said grantors for certain good and valuable considerations moving them thereto, and particularly the sum of
Three Hundred and 00/100----- Dollars (\$ 300.00), to them paid by the Grantee the receipt of
which is hereby acknowledged, have bargained and sold, and by these presents do hereby bargain, sell and convey unto the said grantee, its successors
and assigns, the following described lands in Charleston Township, Swain County, State of North
Carolina, particularly described as follows, viz:

NOTE: All bearings in this description were turned from the true meridian and all
distances are expressed in chains of 66 feet.

The grantors covenant to and with the grantee, its successors and assigns: That they are the owners of and are seized of the premises in fee; that they have good right to convey the same in fee simple; that the said premises are free and clear from encumbrances, except as hereinafter stated; and, that they will forever warrant and defend their said title to said premises against the claims of any and all persons whatsoever.
