THIS DEED, Made this 9th, day of April, A.D. 1929, by and between Annie Cagle and husband Lee Cagle.

of Swain County, North Carolina, hereinafter called GRANTOR, whether one or more, and THE STATE OF NORTH CAROLINA, hereinafter called GRANTEE:

WITNESSETH:

That the said grantors for certain good and valuable considerations moving them thereto, and particularly the sum of
-----TWO THOUSAND ----- Dollars (\$200.00), to them paid by the Grantee the receipt of
which is hereby acknowledged, have bargained and sold, and by these presents do hereby bargain, sell and convey unto the said grantee, its successors
and assigns, the following described lands in Charleston Township, Swain County, State of North
Carolina, particularly described as follows, viz:

Tract No. 165:

NOTE: All bearings in this description were turned from the true meridian and all distances are expressed in chains of 66 feet.

BEGINNING at corner 1, which is corner 5 of the J.L. Cathey Tract (157), and a corner of the Hardy Clark land, apoint with witnesses, on ridge, set a post scribed C-1; thence with lines of the Hardy Clark land and with the meanders of ridge South 13-34 W. 1.33 chains; South 29-59 W. 3.12 chains; South 22-54 West 2.88 chains; South 18-53 West 4.70 chains; South 27-38 West 2.79 chains; South 72-26 West 4.68 chains, corner 2, a point at corner of wire fence on knob. Set a post scribed C-2 South 23-52 West leaving ridge 3.00 chains public road 4.50 chains, stream flows west 13.94 chains, corner 3, a 6" locust with marks, on ridge top blazed and scribed C-3 South 12-56 East 5.16 chains, corner 4, which is corner 2 of the Lee Wiggins Tract (145-a), a point shown by Lee Cagle as site of hickory corner. Set a post scribed C-4; thence with a line of the Lee Wiggins Tract (145-a) North 68-37 West 7.16 chains, corner 5, which is corner 4 of the Lee Wiggins Tract (153), a 12" spanish oak on bank of old road, on a ridge, shown by Lee Cagle blazed and scribed W-1-1; thence, with line of Lee Wiggins Tract (153), down ridge N. 30-56 West 2.47 chains; North 86-41 West 3.13 chains; South 76-40 West 3.52 chains; North 71-18 West 3.32 chains, a 16" black gum with old marks, blazed and scribed W-2 North 9-40 West 4.77 chains; North 11-44 East 3.33 chains; North 32-16 West 3.31 chains, corner 6, a point on lower side of road, in the line of the Frankwood Mfg. Co. Tract (155), set a post South 32-16 East .27 chain distant from the point; thence, with lines of the Frankwood Mfg. Co. Tract (155) South 86-45 East 3.30 chains, corner 7, a maple with marks, on north bank of road North 32-06 East 8.50 chains, corner 8, which is corner 3 of the Hattie McCracken Tract (154-a), a 6" spanish oak with marks, on a ridge; thence, with the meanders up the ridge, a line of the Hattie McCracken Tract (154-a) North 34-30 East 3.57 chains; North 15-36 East 2.65 chains; North 42-41 East 5.55 chains; North 29-11 East 3.19 chains; North 44-56 East 3.32 chains; North 51-32 East .91 chains, corner 9, which is corner 4 of the J. L. Cathey Tract (157), a cluster chestnuts; thence, with a line of the J. L. Cathey Tract (157), and still with the meanders of the ridge North 85-53 East 3.08 chains; South 59-42 E. 3-51 chains; South 84-30 East 1.83 chains; South 54-54 East 4.70 chains; South 68-38 East 2.20 chains; South 78-20 East 1.37 chains, the place of beginning, containing 66.14 chains.

Also all other pieces, parcels or lots of land or interest in lands located within the area designated by the Secretary of the Interior as the "Great Smokey Mountains National Park."

TO HAVE AND TO HOLD the said premises, above described, with every privilege and appurtenance thereunto belonging, to the said grantee, its successors and assigns, to its and their only use and behoof forever.

The grantors covenant to and with the grantee, its successors and assigns: That they are the owners of and are seized of the premises in fee; that they have good right to convey the same in fee simple; that the said premises are free and clear from encumbrances, except as hereinafter stated; and, that they will forever warrant and defend their said title to said premises against the claims of any and all persons whatsoever.
