THIS DEED Made this 11th day of March A.D. 1932, by and between Lizzie Woody, Nelson Woody and Wf. Kirkland, W.V. Woody, widow, W.A. Cope & Wf. Dollie Cope, J.A. Cross & Wf. Roxie Cross, Pearly Kirkland and Wf. Hattie Kirkland, Oscar Kirkland & Wf. Eva / of Swain County, North Carolina, hereinafter called GRANTORS, whether one or more, and THE STATE OF NORTH CAROLINA, hereinafter called GRANTEE:

WITNESSETH:

That the said grantors for certain good and valuable considerations moving them thereto, and particularly the sum of ONE DOLLAR * * * * * (\$ 1.00), to them paid by the Grantee the receipt of which is hereby acknowledged, have bargained and sold, and by these presents do hereby bargain, sell and convey unto the said grantee, its successors and assigns, the following described lands in Forney Creek Township, Swain County, State of North Carolina, particularly described as follows, viz.:

TRACT NO. 178

BEGINNING at Corner 1, which is corner 11 of the W.T. Woody Tract; thence North 47°00' East, 4.09 chains, Corner 2, which is corner 12 of the W.T. Woody Tract; thence North 62° West, 1.38 chains, Corner 3, which is Corner 13 of the Woody Tract; thence South 38°40' West, 4.09 chains, Corner 4, which is Corner 14 of the said Woody Tract; thence South 56°18' East, to the place of BEGINNING, containing .65 acres, the same being the Forney Creek Cemetery Lot.

(It is hereby requested by the Grantors herein that the tract of land hereby conveyed shall, after it has become a part of the GREAT SMOKY MOUNTAINS NATIONAL PARK, be maintained as a burying ground by the National Park Service).

TO HAVE AND TO HOLD the said premises, above described, with every privilege and appurtenance thereunto belonging, to the said grantee, its successors and assigns, to its and their only use and behoof forever.

The grantors covenant to and with the grantee, its successors and assigns: That they are the owners of and are seized of the premises in fee; that they have good right to convey the same in fee simple; that the said premises are free and clear from encumbrances, except as hereinafter stated; and, that they will forever warrant and defend their said title to said premises against the claims of any and all persons whatsoever.
