THIS DEED, Made this 27<sup>th</sup> day of May, A.D. 19<sup>29</sup> by and between W.L. Myres and Martha Myres, his wife

of Swain County, North Carolina, hereinafter called GRANTORS, whether one or more, and THE STATE OF NORTH CAROLINA, hereinafter called GRANTEE:

## WITNESSETH:

That the said grantors for certain good and valuable considerations moving them thereto, and particularly the sum of ~~THREE~~ THOUSAND FIVE HUNDRED & 00/100----- Dollars (\$ 5,500.00), to them paid by the Grantee the receipt of which is hereby acknowledged, have bargained and sold, and by these presents do hereby bargain, sell and convey unto the said grantee, its successors and assigns, the following described lands in Forney Creek Township, Swain County, State of North Carolina, particularly described as follows, viz:

## Tract (185)

NOTE: All bearings in this description were turned from the true meridian and all distances are expressed in chains of 66 feet.

Lying on the water shed of Eagle Creek, North 66-16 East of Little Shuck Stack Mountain 53.37 chains distant.

BEGINNING at corner 1, a point on the southern boundary of the Smokey Mountain Park North 30-04 East 3.00 chains distant from the old Myres Lynn corner: Thence, North 30-04 West 17.47 chains. Corner 2, a 30" chestnut with old marks and witnesses, shown by W.L. Myres, blazed and scribed W.M. Cor. 2: Thence North 78-20 West 8.51 chains. Corner 3, a 20" dead chestnut with well marked witnesses blazed and scribed W.M. Cor. 3. A 16" chestnut blazed and scribed B.T. W.M. Cor. 3 bears North 77-30 West .28 chains distant: Thence, North 0-01 West 10.00 chains. Prong of Lost Cove Creek flowing East. 14-19 chains Corner 4, a stone with witnesses, Set a 4" sourwood stake scribed W.M. Cor. 4, A 24" black oak blazed and scribed B.T. W.M. Cor. 4 bears North .30 chains distant: Thence, North 51-25 East 19.05 chains. Corner 5, an old chestnut stump with pointers, Set a 4" chestnut stake scribed W.M. Cor. 5. 10" black gum blazed and scribed B.T. W.M. Cor. 5 bears South 38-30 East .40 chains distant: Thence South 88-27 East .20. 90 chains, Corner 6, a 15" spanish oak, well marked with witnesses, blazed and scribed W.M. Cor. 6. A 20" chestnut blazed and scribed B.T. W.M. Cor. 6 bears South 77-30 West .32 chains distant: Thence, North 71-00 East 7.68 chains, East fork Lost Cove Creek flowing Southwest, 22. 38 chains, Corner 7, a point at the end of marked line, set a 4" chestnut post near a chestnut stump scribed W.M. Cor. 7, A 10" dogwood blazed and scribed B.T. W.M. Cor. 7 bears North 74-00 .60 chains distant: Thence, South 22-27 East 29.51 chains, Corner 8, a point in the southern boundary line of the Smokey Mountain Park between Little Shuck Stack Mountain and Bone Valley, Set a 4" locust post in a mound of stones scribed W.M. Cor. 8. a 10" chestnut oak blazed and scribed B.T. W.M. Cor. 8 bears South 76-00 East .54 chains distant: Thence, South 22-27 East 30. 49 chains, the corner of Grant 13752: thence S. 70-35 W. 12.70 chains to point; thence North 88-00 W. 15.00 chains to point; thence N. 77-00 W. 25.00 chains to Lynn; thence N. 30-04 W. 3.00 chains to the place of BEGINNING, containing 318. 61 acres.

Also all other pieces, parcels or lots of land or interest in lands located within the area designated by the Secretary of the Interior as the "Great Smokey Mountain National Park."

TO HAVE AND TO HOLD the said premises, above described, with every privilege and appurtenance thereunto belonging, to the said grantee, its successors and assigns, to its and their only use and behoof forever.

The grantors covenant to and with the grantee, its successors and assigns: That they are the owners of and are seized of the premises in fee; that they have good right to convey the same in fee simple; that the said premises are free and clear from encumbrances, except as hereinafter stated; and, that they will forever warrant and defend their said title to said premises against the claims of any and all persons whatsoever.
