THIS DEED, Made this day of May, A.D. 1929, by and between Jack Calhoun and Bonnie Calhoun, his wife

of Swain County, North Carolina, hereinafter called GRANTORS, whether one or more, and THE STATE OF NORTH CAROLINA, hereinafter called GRANTEE:

WITNESSETH:

That the said grantors for certain good and valuable considerations moving them thereto, and particularly the sum of FIVE HUNDRED & 00/100 Dollars (\$ 500.00), to them paid by the Grantee the receipt of which is hereby acknowledged, have bargained and sold, and by these presents do hereby bargain, sell and convey unto the said grantee, its successors and assigns, the following described lands in Forney reek Township, Swain County, State of North Carolina, particularly described as follows, viz.:

NOTE All bearings in this discription were turned from the true meredian and all distances are expressed in chains of 66 feet.

Lying on the North side of the Little Tennessee River, about 1/4 mile East of Twenty-mile Creek.

BEGINNING at corner 1, which is corner 9 of the Roscoe Marvel tract (186) a chestnut stump, in the Contur line which forms the Tallassee Power Co. boundary, witnessed by a 10" hickory, a 15" red oak and 3" walnut; thence with lines of the Roscoe Marvel Tract (186) N. 38-30 E. 23.86 chains to corner 2 a chestnut stake, on top of the divide witnessed by a 10" pine, a 6" white oak and a 6" spanish oak N. 87-40 W. 3.50 chains to stake on top of divide, corner 3 N. 55-45 W. 5.68 chains, corner 4, a stake, on top of divide N. 36-30 W. 6.65 chains, corner 5, a stake, on top of divide S. 76- 30 W. 7.68 chians, corner 6, a stake on top of divide, witnessed by 12" spanish oak, 12" red oak and 10" post oak, S. 38-30 W. 21.00 chians corner 7, a locust stake, at the intersection with the contur which forms the boundary of the Tallassee Power Co. land, witnessed by a 10" chestnut oak, a 4" locust and a 6" hickory; thence with the meanders of the contur, which forms the boundary of the Tallassee Power Co. land S. 75-39 E. 2.50 chains to iron pipe S. 76- 58 E. 3.71 chains to a point N. 78- 34 E. 3.02 chains to iron pipe S. 5-45 W. 2.58 chains to a point S. 34-58 E. 4. 92 chains to iron pipe N. 67-02 E. 1.52 chains to a point S. 65-02 E. 5.30 chains to the place of BEGINNING. Containing 45. 27 acres.

TO HAVE AND TO HOLD the said premises, above described, with every privilege and appurtenance thereunto belonging, to the said grantee, its successors and assigns, to its and their only use and behoof forever.
The grantors covenant to and with the grantee, its successors and assigns: That they are the owners of and are seized of the premises in fee; that they have good right to convey the same in fee simple; that the said premises are free and clear from encumbrances, except as hereinafter stated; and, that they will forever warrant and defend their said title to said premises against the claims of any and all persons whatsoever.
