WITNESSETH:

That the said grantors for certain good and valuable considerations moving them thereto, and particularly the sum of SEVENTYFIVE & 00/100 Dollars (\$75.00), to them paid by the Grantee the receipt of which is hereby acknowledged, have bargained and sold, and by these presents do hereby bargain, sell and convey unto the said grantee, its successors and assigns, the following described lands in Ocona Luffy Township, Swain County, State of North Carolina, particularly described as follows, viz.: Being all the rights, title and and interest reserved by the said Jessie J. Bradley in a deed to W.W. Wilson, made on the 16th day of March 1927 and Registered in Book 53 page 496, Records of Deeds for Swain County North Carolina. It is the intention of this deed to convey all and every the rights, title and interests reserved in the above deed and reference is hereby made to said record for the description of said land and the resivation made.

TO HAVE AND TO HOLD the said premises, above described, with every privilege and appurtenance thereunto belonging, to the said grantee, its successors and assigns, to its and their only use and behoof forever.

The grantors covenant to and with the grantee, its successors and assigns: That they are the owners of and are seized of the premises in fee; that they have good right to convey the same in fee simple; that the said premises are free and clear from encumbrances, except as hereinafter stated; and, that they will forever warrant and defend their said title to said premises against the claims of any and all persons whatsoever.
