of Buncombe County, North Carolina, hereinafter called GRANTORS, whether one or more, and THE STATE OF NORTH CAROLINA, hereinafter called GRANTEE:

WITNESSETH:

That the said grantors for certain good and valuable considerations moving them thereto, and particularly the sum of Thirty Six Thousand Two Hundred Twenty two and 86/100----- Dollars (\$36222.86), to them paid by the Grantee the receipt of which is hereby acknowledged, have bargained and sold, and by these presents do hereby bargain, sell and convey unto the said grantee, its successors and assigns, the following described lands in Ocona Lufthy..... Township, Swain..... County, State of North

Carolina, particularly described as follows, viz.: Being a tract of land containing five thousand four hundred and eighteen, and thirty-one hundredths acres, joining the lands of Champion Fibre Company, and others, and being the same boundary of land described in the condemnation proceedings now pending in Buncombe County, North Carolina, in the case of State of North Carolina versus James A. Martin, et al., to which reference is hereby made for a more perfect and particular description of said land; and being likewise described in a plat marked "Exhibit B" hereto attached to this deed of conveyance.

Excepting, however, from the operation of this conveyance, the rights and interests conveyed and described in the timber deed from James A. Martin and wife to Cherry River Boom and Lumber Company, by deed dated the 5th day of September, 1925, which is duly recorded in the office of the Register of Deeds of Swain County, N. C., in Book 52, at page 213, et seq.

Said lands are on the waters of Bradley's Fork, Upper Big Creek, and Lower Big Creek, and West Fork, in said Ocona Lufty Township, in Swain County, N. C., and being the lands purchased by the Grantors from James A. Martin and wife, which said deed is duly recorded in the office of the Register of Deeds of Swain County, N. C., in Book 59, at page 8 et seq.

TO HAVE AND TO HOLD the said premises, above described, with every privilege and appurtenance thereunto belonging, to the said grantee, its successors and assigns, to its and their only use and behoof forever.

The grantors covenant to and with the grantee, its successors and assigns: That they are the owners of and are seized of the premises in fee; that they have good right to convey the same in fee simple; that the said premises are free and clear from encumbrances, except as hereinafter stated; and, that they will forever warrant and defend their said title to said premises against the claims of any and all persons whatsoever.
