THIS DEED, Made this 19th day of September, A.D. 1929, by and between G.C. Jenkins and wife Myrtle Jenkins of Swain County, North Carolina, hereinafter called GRANTORS, whether one or more, and THE STATE OF NORTH CAROLINA, hereinafter called GRANTEE:

WITNESSETH:

That the said grantors for certain good and valuable considerations moving them thereto, and particularly the sum of Four Hundred \$ No/100 Dollars (\$ 400.00), to them paid by the Grantee the receipt of which is hereby acknowledged, have bargained and sold, and by these presents do hereby bargain, sell and convey unto the said grantee, its successors and assigns, the following described lands in Township, Swain County, State of North Carolina, particularly described as follows, viz.:

TRACT NO. 38:

NOTE: All bearings in this description were turned from the true meredian, and all distances are expressed in chains of 66 feet. Lying on the East side of Ocona Luffy River, a short distance below Smokemont, BEGINNING at corner 1, which is corner 2 of the L.A.W. Maney Tract (33), point where the old Maney line intersects the public road; thence North 46-49 E. 15.57 chains, corner 2, a stake with witnesses, on a ridge; thence N. 30-37 W. .70 chains, corner 3, which is corner 1 of the Leonard Conner Tract (37), a small chestnut with corner marks and witnesses on top of the ridge. A 14" spanish oak, blazed and scribed B.T.M. 3, bears N. 5-00 E. .40 chain distant; thence, with two lines of the Leonard Conner Tract (37) N. 53-20 W. 1.80 chains, corner 4, a stake on ridge top; S. 47-15 W. 15.70 chains corner 5, a point in public road; thence S. 46-54 E. with the public road 2.63 chains, the place of BEGINNING, containing 3.90 acres. Also all other peices, parcels or lots of land or interest in lands located within the area designated by the Secretary of the Interior as the "Great Smoky Mountain National Park."

TO HAVE AND TO HOLD the said premises, above described, with every privilege and appurtenance thereunto belonging, to the said grantee, its successors and assigns, to its and their only use and behoof forever.

The grantors covenant to and with the grantee, its successors and assigns: That they are the owners of and are seized of the premises in fee; that they have good right to convey the same in fee simple; that the said premises are free and clear from encumbrances, except as hereinafter stated; and, that they will forever warrant and defend their said title to said premises against the claims of any and all persons whatsoever.
