WITNESSETH:

That the said grantors for certain good and valuable considerations moving them thereto, and particularly the sum of
EIGHT HUNDRED Dollars (\$800.00), to them paid by the Grantee the receipt of

which is hereby acknowledged, have bargained and sold, and by these presents do hereby bargain, sell and convey unto the said grantee, its successors and assigns, the following described lands in Township, Swain County, State of North

Carolina, particularly described as follows, viz: T. R. A. C. T. N. O. 7.1:

NOTE: All bearings in this description were turned from the true meridian, and all distances are expressed in chains of 66 feet.

Lying between the Raven's Fork of Ocoee Lufthy River and the Logging railway of the Parsons Pulp & Lumber Company about one-half mile above the sawmill of the above named company.

BEGINNING at corner 1, which is corner 2 of the A. J. Mathews Tract (72), a point in Raven's Fork, and in the line of the Parsons Pulp & Lumber Company Tract (68); thence South 71-30 E. with a line of the A. J. Mathews Tract (72) 3.62 chains, corner 2 a point in the line of the D. C. Gass Tract (59); thence N. 21-06 E. with a line of the D. C. Gass Tract (59) 1.17 chains, Corner 3, which is corner 1 of the Verne Quiet Tract (70); thence N. 71-30 W. 3.70 chains, Corner 4, a point in the river, and in the line of the Parsons Pulp & Lumber Co. Tract (68); thence S. 17-40 W. with line of the Parsons Tract 1.17 chains, the place of BEGINNING, containing .43 acres.

Also all other pieces, parcels or lots of land or interest in lands located within the area designated by the Secretary of the Interior as the "Great Smoky Mountains National Park".

The grantors covenant to and with the grantee, its successors and assigns: That they are the owners of and are seized of the premises in fee; that they have good right to convey the same in fee simple; that the said premises are free and clear from encumbrances, except as hereinafter stated; and, that they will forever warrant and defend their said title to said premises against the claims of any and all persons whatsoever.
