THIS DEED, Made this 20th day of August, A.D. 1929, and between T.N. Smith and wife S.A. Smith of Swain County, North Carolina, hereinafter called GRANTORS, whether one or more, and THE STATE OF NORTH CAROLINA, hereinafter called GRANTEE:

WITNESSETH:

That the said grantors for certain good and valuable considerations moving them thereto, and particularly the sum of Thirty Eight Hundred ~~-----~~ Dollars (\$ 3800.00), to them paid by the Grantee the receipt of which is hereby acknowledged, have bargained and sold, and by these presents do hereby bargain, sell and convey unto the said grantee, its successors and assigns, the following described lands in Swain Township, Swain County, State of North Carolina, particularly described as follows, viz.:

T.R.A.C.T.N.G. 7.6.

NOTE: All bearings in this description were turned from the true meridian, and all distances are expressed in chains of 66 feet.

Lying in the eastern water-shed of Oconee Lufty River, about 15 chains below the mouth of Ravens Fork Creek.

BEGINNING at corner 1, a small marked sycamore on East bank of river, common corner with J.D.S. McMahan Tract (75), running thence with nine lines of the J.D.S. McMahan Tract (75) South 84-~~59~~⁵⁹ East 17-74 chains, corner 2, a point; North 8-51 East 3.07 chains, corner 3, a planted stone; South 74-04 East 6-73 chains, corner 4, a large chestnut with marks; North 82-17 East 7-07 chains, corner 5, an 8" chestnut with chestnut oak witness; North 53-15 East 4-2 chains, corner 6, a post with chestnut witness, scribed S. on South and N. on North; South 64-28 East 9-20 chains, corner 7, a post scribed N. and S. at intersection with marked line; North 70-29 East 1.78 chains, corner 8, a chestnut on the bank of stream blazed and scribed N.S. beside a chestnut stump; South 65-30 East 11-14 chains, corner 9, a locust post scribed N.S., a 6" sourwood bears South 45-00 West .08 chains distant scribed B.T.S.; South 1-06 West 3.69 chains, corner 10, a post in the Indian Boundary line, scribed I.B.M. & S., a 16" chestnut bears South 35-00 West .04 chains distant; thence with the Indian Boundary line and ridge as it meanders; South 66-09 West 3.36 chains; North 66-14 West 6.44 chains; North 76-53 West 5.10 chains; South 56-01 West 2.22 chains; North 64-59 West 3.47 chains; North 52-09 West 3-74 chains; North 72-55 West 12.94 chains, corner 11, an iron post on East side of branch, thence down the meanders of the branch South 58-56 West 1.77 chains; South 10-05 West 3.58 chains; South 33-11 West 3.35 chains; South 1-58 East 9.48 chains, corner 12, a point in center of river opposite mouth of branch; thence, up center of river North 71-01 West 9-57 chains; North 50-57 West 8.88 chains; North 6-44 West 9-72 the place of beginning, containing 43.07 acres.

Also all other pieces, parcels or lots of land or interest in lands located within the area designated ~~now~~ by the Secretary of the Interior as the "Great Smoky Mountain National Park."

TO HAVE AND TO HOLD the said premises, above described, with every privilege and appurtenance thereunto belonging, to the said grantee, its successors and assigns, to its and their only use and behoof forever.

The grantors covenant to and with the grantee, its successors and assigns: That they are the owners of and are seized of the premises in fee; that they have good right to convey the same in fee simple; that the said premises are free and clear from encumbrances, except as hereinafter stated; and, that they will forever warrant and defend their said title to said premises against the claims of any and all persons whatsoever.
