THIS DEED, Made this 30th day of May, A.D. 1929., by and between
Hugh N. Lambert, Widower

of Swain County, North Carolina, hereinafter called GRANTORS, whether one or more, and THE STATE OF NORTH CAROLINA, hereinafter called GRANTEE:

WITNESSETH:

That the said grantors for certain good and valuable considerations moving them thereto, and particularly the sum of Six Hundred Seventy five & 80/100 Dollars (\$675.80-), to them paid by the Grantee the receipt of which is hereby acknowledged, have bargained and sold, and by these presents do hereby bargain, sell and convey unto the said grantee, its successors and assigns, the following described lands in Ocona Luffy Township, Swain County, State of North Carolina, particularly described as follows, viz.:

NOTE: All bearings in this description were turned from the true meridian and all distances are expressed in chains of 66 feet. Lying in the Western water-shed of the Ocona Luffy River at the head of Lambert Branch; BEGINNING at Corner 1, a locust post at corner of wire fence and corner 5 of the J. H. Reagan Tract (84); thence with the Reagan Tract (84) N. 34-44 E. 11.37 chains, corner 2, a point on a spur, set a sassafras post, an 8" Black oak bears S. 2-00 W. .25 chains distant scribed B. T. F., corner 7 of the Dougherty Tract (80), corner 7 of the Reagan Tract (84), and a common corner to the Floyd Tract (89); thence with the Floyd Tract (89) and the meanders of the ridge S. 59-24 W. 1.58 chains; S. 79-42 W. 7.63 chains; S. 50-51 W. 3.01 chains; S. 55-25 W. 5.45 chains; N. 88-46 W. 1.65 chains; S. 74-37 W. 3.89 chains; S. 77-52 W. 3.03 chains; S. 72-33 W. 2.98 chains; S. 80-51 W. 2.62 chains; N. 78-32 W. 1.67 chains; S. 69-24 W. 3.94 chains; S. 58-28 W. 2.67 chains; S. 50-35 W. 4.41 chains, corner 4, a large white oak with old marks and witnesses scribed B. a common corner to the Caloway and Weaver Tract (92) and the Reagan Tract (84); thence with the Reagan Tract (84) and the meanders of the ridge S. 89-16 E. 8.66 Chain, corner 5, a post oak-point of ridge, scribed R. B., a 14" locust bears N. 32-00 W. 15 chain distant, scribed B. T. B., South 23-41 E. 7.03 chains, corner 6, a dead chestnut on a ridge, set a post scribed R. B. S. 56-18 E. 6.82 chains, corner 7, a Hickory on a ridge S. 62-53 E. 4.75 chains, S. 52-23 E. 2.19 chains; S. 65-32 E. 3.28 chains; South 72-13 E. .96 chains; S. 45-18 E. 7-18 chains, the place of beginning, containing 67.58 acres.

The grantors covenant to and with the grantee, its successors and assigns: That they are the owners of and are seized of the premises in fee; that they have good right to convey the same in fee simple; that the said premises are free and clear from encumbrances, except as hereinafter stated; and, that they will forever warrant and defend their said title to said premises against the claims of any and all persons whatsoever.
