THIS DEED, Made this 28th day of May, A.D. 19 29 by and between  
J. H. Reagan and wife E. A. Reagan  
of Swain County, North Carolina, hereinafter called GRANTORS, whether one or more, and THE STATE OF NORTH CAROLINA, hereinafter called GRANTEE:

WITNESSETH:

That the said grantors for certain good and valuable considerations moving them thereto, and particularly the sum of ONE THOUSAND DOLLARS Dollars (\$ 1000.00), to them paid by the Grantee the receipt of which is hereby acknowledged, have bargained and sold, and by these presents do hereby bargain, sell and convey unto the said grantee, its successors and assigns, the following described lands in Ocona Lufly Township, Swain County, State of North Carolina, particularly described as follows, viz.:

Tract No. (84): NOTE: A; bearings in this description were turned from the true meridian and all distances are expressed in chains of 66 feet lying in the Western water shed of the Ocona Lufly River, and on both sides of Lambert Branch. BEGINNING at Station 1, a large white oak with old marks and witnesses, scribed B. A common corner to the J. M. Bradley Tract (87), and the Calloway and Weaver Tract (92); thence with four lines and two meanders of the Bradley tract (87) South 89-16 East 8.66 chains, (corner 2), a post on point of ridge, scribed R. B., a 14" locust bears N. 32-00 West .15 chain distant, scribed B. T. B. South 23-41 East 7.03 chains (corner 3), a dead chestnut on a ridge, set a post scribed R. B. South 36-18 East 6.82 chains, (Corner 4), a hickory on a ridge South 62-53 East 4.76 Chains; South 52-23 East 2.19 chains; South 65-32 East 2.28 chains; South 73-13 East .26 chains; South 45-18 East 7.18 chains, (Corner 5), a locust post at corner of wire fence, common corner with the Bradley Tract (87) North 34-44 East 11.37 chains, (Corner 6), a point on a spur, set a sassafras post, an 8" black oak bears South 2-00 West. 25 chains distant scribed B. T. R. North 6-53 West 3.17 chains; North 7-17 East 1.45 chains; North 14-43 West 3.43 chains; North 7-20 West 2.60 chains; North 10-55 East 4.91 chains North 8-17 East 3.82 chains; North 18-18 East 3.47 chains; North 12-57 East 2.51 chains; North 42-00 East 3.40 chains, (Corner 7), a point with chestnut witnesses on high knob, set a post scribed R. B. D., a 24" chestnut bears North 75-00 West .27 chain distant scribed B. T. F. Corner 7 of the Ora Daugherty Tract (80), and common corner to the F. and E. Floyd Tract (89); thence with the Dougherty Tract (80) and the ridge meanders South 20-43 East 1.16 chains; South 31-11 East 3.15 Chains; South 49-01 East 1.30 chains, Corner 8), a chestnut tree, corner 6 of the Dougherty Tract (80) and corner 2 of the DeBord Tract (81); thence with the DeBord Tract (81) and the meanders of the ridge South 21-30 East 6.79 chains; South 10-25 East 2.74 chains; South 18-35 East 4.10 chains; South 9-24 East 1.75 chains; South 3-18 East 1.68 chains; South 54-17 East 4.77 chains; South 29-12 East 2.22 chains, a point shown by B. M. Reagan, as site of common corner to the Reagan and DeBord Tracts, set a post in a mound of stones, scribed D. and R.; thence with the Reagan Tract (82) and the ridge meanders South 3-08 East 1.59 Chains; South 16-30 East 5-48 chains; South 21-09 East 11.63 chains; South 25-01 East 1.84 chains; South 43-04 East 5.09 chains; South 64-22 East 1.82 chains; South 52-48 East 7.04 chains; South 75-56 East 3.61 chains; South 25-26 East 4.98 chains; South 32-16 East 3.64 chains, (corner 9) a point in the Indian Boundary line; thence with three lines of the Indian Boundary line, North 62-31 West 36-37 chains, (Corner 10) a point near edge of field, set a locust post scribed I. B., a 12" poplar bears South 55-00 East .25 chains distant, scribed B. T. North 82-50 West 13.27 chains, Corner 11, a point at the corner of old fence, set a locust post scribed I. B., an 8" poplar bears South 15-00 E. .37 chain distant, scribed B. T. South 2-48 West 7.91 Chains, (Corner 12) a point in old fence row on ridge, set a post scribed I. B. R. B., an 8" walnut bears North 75-00 West .20 chain distant, scribed B. T. R. a common corner to the J. M. Bradley Tract (87-a) thence with the Bradley tract (87-a) South 63-35 West 6.64 chains, (Corner 13) a point in the Indian Boundary line, set a post, scribed I. B. R. B.; thence with the Indian Boundary line North 37-49 West 48.79 chains (Corner 14), a point in the Indian Boundary line, set a post scribed I. B. R. C. W., a 6" white oak bears North .18 chain distant, scribed B. T. C. W., a common corner to the Calloway and Weaver Tract (92); thence with the Calloway and never Tract (92) North 70-35 East 3.23 chains, the point of beginning. Containing 131. 77 acres.

TO HAVE AND TO HOLD the said premises, above described, with every privilege and appurtenance thereunto belonging, to the said grantee, its successors and assigns, to its and their only use and behoof forever.

The grantors covenant to and with the grantee, its successors and assigns: That they are the owners of and are seized of the premises in fee; that they have good right to convey the same in fee simple; that the said premises are free and clear from encumbrances, except as hereinafter stated; and, that they will forever warrant and defend their said title to said premises against the claims of any and all persons whatsoever.
