THIS AGREEMENT, made this 18th day of October, A.D. 1929, by and between William Stepp and wife, Oma Stepp

of Swain County, North Carolina, hereinafter called the VENDOR, whether one or more, and THE STATE OF NORTH CAROLINA, hereinafter called the VENDEE:

WITNESSETH:

That whereas Vendor is the owner of certain lands within the area designated by the Secretary of the Interior of the United States of America for a national park to be known as the Great Smoky Mountains National Park, under the provisions of the Act of Congress, 44 Statutes at Large 616, which lands are also embraced within the boundary mentioned in Chapter 48 of the Public Laws of North Carolina, Session of 1927:

And whereas the Vendee is desirous of acquiring title to said premises for inclusion in said Great Smoky Mountain National Park; NOW, THEREFORE, the Vendor for and in consideration of the sum of ONE DOLLAR to him in hand paid, receipt of which is hereby acknowledged, and other valuable considerations moving him thereto, agrees to sell and convey in fee simple to the Vendee at the option and upon the demand

of said Vendee, its successors and assigns, at any time within months from the date of these presents, all those certain lands situate in Township, County and State aforesaid, containing

acres, more or less, adjoining the lands of

and others, bounded and described as follows: TRACT NO. 86.

NOTE: All bearings in this description were returned from the same in 1861 and all distances are expressed in chains of 66 feet.

Lying about 30 chains West of the Ocona Luffy River, and about 12 chains south of Lambert Branch.

BEGINNING at Corner 1, a black oak and corner 3 of the C. W. Parker Tract (79a) and the meanders of the ridge N. 24-25 E. 4.42 chains; N. 34-20 W. 2.97 chains; N. 71-41 W. 4.61 chains; S. 65-18 W. 1.68 chains; N. 58-40 W. 3.94 chains; N. 69-30 W. 1.56 chains; N. 63-04 W. 8.31 chains; N. 82-10 W. 1.13 chains, N. 15-54 W. 3.14 chains; N. 73-06 W. 2.59 chains; N. 58-44 W. 2.94 chains; S. 74-25 W. .73 chains, a fallen chestnut which is corner 1 of the L. Duckett Tract (85), and corner 4 of the C. W. Parker Tract (79a); thence with the Duckett Tract (85) and the meanders of the ridge S. 85-18 W. 3.94 chains; N. 78-21 W. 1.62 chains; S. 88-16 W. 2.53 chains; N. 75-48 W. 2.13 chains; N. 87-57 W. 107 chains; N. 59-41 W. 3.53 chains; N. 86-00 W. 2.17 chains, corner 2, a point which is corner 5 of the L. Duckett Tract (85), and a point in the Indian Boundary; thence with two lines of the Indian Boundary S. 37-19 E. 24.85 chains, corner 3, a locust post on S. W. bank of old road, scribed I.B. S. 87-00 E. 27.23, the place of beginning, containing 43.55 acres.

Also all other pieces, parcels or lots of land or interest in lands located within the area designated by the Secretary of the Interior as the "Great Smoky Mountains National Park".

The Vendor covenants that at the date of this instrument the title to said land is clear and free of encumbrances, except as follows:

The Vendor agrees to procure and have recorded at his own expense all such deeds and other evidences of title which he may be advised by the Attorney-General of North Carolina or his assistants are necessary and proper to vest in the Vendee good and sufficient title to said land.

The price to be paid for said lands by the Vendee is the sum of \$1,000.00, payable as follows: Cash upon delivery of deed

In the event the price is by the acre, such acreage shall be ascertained by an accurate survey made by the Vendee.
In the event that the title of the Vendor is not satisfactory to the Attorney-General of North Carolina, title may be acquired by the institution of condemnation proceedings, in which event the evidence to be presented by both parties to this agreement before the appraiser or appraisers in condemnation proceedings in the valuation of said land shall be the same price as stipulated in this agreement.
It is agreed that any demand or notice to the Vendor on the part of the Vendee of the acceptance hereof shall be through the Chairman or Executive Secretary of the North Carolina Park Commission.
