WITNESSETH:

That the said grantors for certain good and valuable considerations moving them thereto, and particularly the sum of THIRTEEN HUNDRED, SEVENTY & SIX & 97/100-----Dollars (\$ 1376.97), to them paid by the Grantee the receipt of which is hereby acknowledged, have bargained and sold, and by these presents do hereby bargain, sell and convey unto the said grantee, its successors and assigns, the following described lands in Township, Swain County, State of North Carolina, particularly described as follows, viz.:

All of such lands as are described in deed from Charlotte Lytle Callaway and A.H. Weaver, dated January 12, 1924, and registered in the office of the Register of Deeds of Swain County, in Book 54 of Deeds, at page 555, to which reference is hereby made for full and complete description. See also deed from Smith to Weaver, dated 12-3-26, registered in Swain County, Book 54, at page 559. It is understood that after the execution of the deed above referred to, the title shall be conveyed under subsequent deed containing an accurate description of the premises to be conveyed.

TO HAVE AND TO HOLD the said premises, above described, with every privilege and appurtenance thereunto belonging, to the said grantee, its successors and assigns, to its and their only use and behoof forever.

The grantors covenant to and with the grantee, its successors and assigns: That they are the owners of and are seized of the premises in fee; that they have good right to convey the same in fee simple; that the said premises are free and clear from encumbrances, except as hereinafter stated; and, that they will forever warrant and defend their said title to said premises against the claims of any and all persons whatsoever.

The grantors further covenant to make, acknowledge and deliver all such deeds and writings as they may be advised by council learned in the law to vest in the grantee by correct description of such lands as may be properly embraced in the conveyance above referred to by horizontal measurement.

It is understood that such subsequent conveyance shall supercede in description and warranty the conveyance hereby made
