WITNESSETH:

That the said grantors for certain good and valuable considerations moving them thereto, and particularly the sum of -----Five Hundred ----- Dollars (\$ 500.00, to them paid by the Grantee the receipt of which is hereby acknowledged, have bargained and sold, and by these presents do hereby bargain, sell and convey unto the said grantee, its successors and assigns, the following described lands in Ocona Luffy Township, Swain County, State of North Carolina, particularly described as follows, viz:

NOTE: All bearings on this discription were turned from the true meredian and all distances are expressed in chains of 66 feet. Lying on the western bank of Mingus Creek and on both sides of Woody Branch, BEGINNING at corner 1, an old stake, with a 30" chestnut tree witness scribed S.T.J.T. Cor. II. Corner 5 of the Enloe tract (99), Corner 15 of the Coburn Tract (100), and a common corner with the Treadway Tract (98); thence, with two lines of the Enloe Tract (99) South 89-51 West 17.58 chains; Corner 2, a 20" maple scribed E.K. Cor. II South 3-06 West 13.18 chains, corner 3, a point on top of a ridge, a 36" chestnut tree bears South 35-00 East .18 chains distant, scribed B.T.J.J. E. Cor. No. I. a common corner to the Ed Floyd Tract (88-a), corner I of the Enloe Tract (99); thence with the Folyd Tract (88-a) South 2-16 West 12.26 chains, Corner 4, a chestnut stake scribed E.K. Cor. III, corner 8 of the W.H. Hoyle Tract (95); thence with Hoyle Tract (95) South 88-39 East 28.71 chains, Corner 5, a stake with witnesses on the east bank of Mingus Creek and in the line of the Mrs. James Treadway Tract (98); thence up the meanders of Mingus Creek and with the Treadway Tract (98) N. 26-58 East .82 chains; North 16-41 East 1.40 chains; North 12-34 East 1.77 chains; North 5-04 West 1.95 chains; North 14-10 East 1.41 chains; North 7-00 West 2.20 chains; North 24-58 West 2.86 chains; North 29-58 West 2.31 chains; North 35-04 West 1.77 chains; North 48-14 West 1.94 chains; North 25-51 West 3.31 chains; North 34-57 West 8-09 chains, the place of beginning, containing 66.38 acres.

The grantors covenant to and with the grantee, its successors and assigns: That they are the owners of and are seized of the premises in fee; that they have good right to convey the same in fee simple; that the said premises are free and clear from encumbrances, except as hereinafter stated; and, that they will forever warrant and defend their said title to said premises against the claims of any and all persons whatsoever.
