THIS DEED, Made this 3rd day of May, A.D. 1929, by and between James W. Treadway and wife Ida Treadway of Swain County, North Carolina, hereinafter called GRANTORS, whether one or more, and THE STATE OF NORTH CAROLINA, hereinafter called GRANTEE:

WITNESSETH:

That the said grantors for certain good and valuable considerations moving them thereto, and particularly the sum of Five Hundred Dollars (\$ 500.00), to them paid by the Grantee the receipt of which is hereby acknowledged, have bargained and sold, and by these presents do hereby bargain, sell and convey unto the said grantee, its successors and assigns, the following described lands in Ocona Lufly Township, County, State of North Carolina, particularly described as follows, viz:

TRACT NO. 98:

NOTE: All bearings in this description were turned from the true meridian and all distances are expressed in chains of 66 feet. Lying on the east bank of Mingus Creek, Opposite the mouth of Woody Branch, BEGINNING AT corner I, an old stake and corner 14 of the J.E. Coburn Tract (100), witness a 30" chestnut scribed B.T. J.T. Cor. II common corner to the R.J. Roane Tract (97); thence with the Roane Tract (97) S. 4-07 W 27.10 chains, corner 2, a hickory stake in place of white oak; scribed T.T. Cor. III, a 14" chestnut oak bears S. 20-00 W ..18 chain distant, scribed B.T.J.T. Cor. III, N. 87-05 W. 13. 17 chains, corner 3, a 30 " birch on West bank of Mingus Creek, scribed J.T. Cor. IV, and corner 1 of the W.M. Hoyle Tract (95); thence with the Hoyle Tract (95) N. 35-33 E. 1.87 chains, corner 4, a stake with witnesses on east bank of Mingus Creek, corner 5 of the Elbert Keener Tract (96); thence with the Keener Tract (96), and the meanders of Mingus Creek N. 26-58 E. .82 chains; N. 15-41 E. 1.40 chains; N. 12-34 E. 1.77 chains; N. 5-04 W. 1.95 chains; N. 14-10 E. 1.41 chains; N.7-00 W. 2.20 chains; N. 24-58 W. 2.86 chains; N. 29-58 W. 2.31 chains; N. 35-04 W. 1.77 chains; N. 48-14 W. 1.94 chains; N. 25-51 W. 3.31 chains; N. 34-57 W. 8.09 chains, corner 5, an old stake with a 30" chestnut tree, witness scribed B.T.J.T. II, corner 5 of the Enloe Tract (99), corner of the Elbert Keener Tract (96), and corner 15 of the Coburn Tract (100); thence with the Coburn Tract (100) S. 87-08 E. 23.91 chains, the place of BEGINNING, containing 41.56 acres.

TO HAVE AND TO HOLD the said premises, above described, with every privilege and appurtenance thereunto belonging, to the said grantee, its successors and assigns, to its and their only use and behoof forever.

The grantors covenant to and with the grantee, its successors and assigns: That they are the owners of and are seized of the premises in fee; that they have good right to convey the same in fee simple; that the said premises are free and clear from encumbrances, except as hereinafter stated; and, that they will forever warrant and defend their said title to said premises against the claims of any and all persons whatsoever.
