J U D G M E N T

Whereas, in the above entitled cause a decree was duly and regularly entered by the Clerk of this Court on the 19 day of March, 1931, which said decree is duly recorded in the Office of the Register of Deeds of Swain County, in Book #56, at page 546, et seq., decreeing that the State of North Carolina is the owner of the various pieces, parcels and portions of land therein fully described; and

Whereas, the respondent, T.C.Queen, excepted and appealed from the award rendered him by the appraisers in said cause as to his tracts of land, to-wit, tracts referred to in said proceedings and maps as Numbers 99 and 99A, and from the judgment of the Clerk of the Superior Court awarding him the amount allowed by the Commissioners, or a jury of view; and

Whereas, said appeal came on for trial at this term of court before the Honorable Cameron F. MacRae, Judge, and a jury, when and where His Honor submitted the issue to be found in the record to the jury, and the jury having assessed the amount the said T.C.Queen is entitled to recover at \$12.50 per acre for tract No. 99A, which tract contains 124.46 acres; and having assessed the value of Tract No. 99 at \$8.00 per acre, which said tract contains 43.93 acres: 99A: \$1555.75 99: \$351.44 Total = \$1907.19 Original Final Judgment (56-546): \$1010.94

Now, Therefore, it is considered, ordered and adjudged that said final decree hereinabove referred to be, and the same is hereby modified and amended so as to adjudge that the said T.C.Queen is entitled to an award in the amounts hereinabove stated, the same to be paid into the office of the Clerk of the Superior Court in accordance with and for the purposes provided in said decree heretofore entered in this action before the Clerk, and upon payment thereof the State of North Carolina is the owner in fee of said Tracts of land and the said T.C.Queen is adjudged thereafter to have and to hold no interest in the same.
