

The lands embraced within the above tracts all lie at Smokemont and are a part of a tract originally belonging to H. J. Beck. They are in fact merely subdivisions of this tract as will be shown by the "abstract of these tracts hereinafter set out. H. J. Beck died leaving a will in which he devised all of his land on the west side of the river to the children of his second wife. The lands so devised cover all of the above tracts except a small portion of Tract 32 which lies West of the Cathcart line.

The history of the titles to these tracts is practically the same down to and including the will from H. J. Beck and an attempted partition between the devisees of said Beck or those claiming under them.

GRANT NO. 224.

1. Grant No. 224 was issued to William Cathcart on August 9, 1796, for a tract containing 33280 acres. This grant covers all of Tract No. 47. It is registered in Buncombe County in which county the lands were situated at the time of the issuance of this grant and is set out on page 169 of the Abstract of Title to Tract No. 11.

2. The title under this grant down to and including a deed dated November 7, 1840, from John Brown as Agent and Attorney in Fact for James Lattimore, Margaret Lattimore and Elizabeth Lattimore, Executors of George Lattimore, Deceased, to William H. Thomas. The several conveyances vesting the title to the lands covered by grant No. 224 in the said W. H. Thomas are set out in the Abstract of title to Tract No. 11, pages 169 to 182 inclusive.

3. The next conveyance we find of record for these lands is a deed from James R. Thomas, Administrator of William H. Thomas, Deceased, to H. J. Beck. This deed conveys a tract of 135 acres which covers all of tract 47 and also covers tracts 48, 39a, 101, 102, 103, 106, 107 and 108 and all of tract 32, lying within the Cathcart grant. The authority under which this deed was executed by said J. R. Thomas, as Administrator, is not of record in Swain County. It is, however, of record in Haywood or Jackson County and will be supplied for this abstract. The deed from J. R. Thomas, Administrator of William H. Thomas to H. J. Beck is set out on page 211 of the Abstract of title to Tract No. 11.

GRANT NO. 1399.

4. Grant No. 1399 was issued to John Fergus on December 11, 1804 for a tract of 300 acres. This grant covers a small portion of tract No. 47 at the northeast corner. This grant was issued while the lands embraced therein were included in Buncombe County and the grant is registered in that county and is set out on page 273 of the Abstract of title to Tract No. 39.

5. We do not find any conveyance of record from John Fergus to John Tomlinson covering this grant.

6. The next conveyance we have is a deed from John Tomlinson to Jesse Cornwell, dated February 25, 1807, conveying the lands described in grant 1399. This deed is recorded in Haywood County, and is set out on page 209, Abstract of Title T act No. 33.

7. On December 30, 1808, Jesse Cornwell executed a deed to John Beck, conveying the southern half of grant No. 1399. This deed would cover the portion of Tract No. 32 embraced in Grant 1399, and also tract No. 39a, 102, 101 and part of tract No. 108. This deed is registered in Haywood County and is set out on page 209 of the Abstract of title to Tract No. 33.

8. By deed dated October 14, 1859, John Beck conveyed to Henry J. Beck a tract of land described as lying on both sides of the west fork of Oconaluftee River and being the lands which he, John Beck, purchased from Jesse Cornwell. The description is the same as in the foregoing deed from Jesse Cornwell to John Beck, except that the third call in the deed as registered is omitted, evidently this was by mistake. The deed further contains an exception of two acres more or less to the Commissioners for the Thirty-Eighth District for common schools. This exception is described as lying at the north end of the tract including a school house for use of schools and for worship while the same is kept up, otherwise to be Henry J. Beck's. We do not find any deed covering this exception and doubtless the school referred to has long been discontinued.

GRANT NO. 237.

9. Grant No. 237 was issued to H. J. Beck on the 19th day of March, 1836. This grant is for a tract of 100 acres and covers a portion of Tract No. 37. However, as the lands covered by Grant No. 237 had already been granted to William Cathcart by a much older grant hereinbefore set out and as H. J. Beck had acquired title under grant 234, the title under No. 237 is not very material. This grant is registered in Swain County and is set out on page 10 of this Abstract.

10. H. J. Beck in whom the lands included in tract 47 had become vested together with the lands covered by tracts 32, 108, 101, 106, 103, 102, 39a and 107 died leaving a will dated January 4, 1899 and duly probated and recorded in the Office of the Clerk of the Superior Court of Swain County, in which he devised to the children of his second wife all of the land on the west side of Oconaluftee River. This devise would include tract No. 47 and the other tracts above mentioned. This will is set out in full on page 213 of the Abstract of title to Tract No. 33.

11. The children of the second wife of said H. J. Beck to whom the above lands were devised are as follows:

12. Rufus H. Beck, one of the above named children, by deed dated April 12, 1902, conveyed to L.A.W. Maney his one-sixth interest in the lands allotted by H. J. Beck, Deceased, to the heirs of Mary Beck (second wife). This deed is recorded in Swain County, and is set out on page 11 of this Abstract.

13. Joseph M. Beck and wife, by deed dated \_\_\_\_\_ day of \_\_\_\_\_, 18\_\_\_\_\_, conveyed to H. Kinsey Beck his one-sixth interest in the lands devised to him by the foregoing will of his father, H. J. Beck. This deed is recorded in Swain County and is set out on page \_\_\_\_\_ of this Abstract.

14. Allen Beck, another of these children, conveyed his interest in the lands devised to him by his father, H. J. Beck, to John T. Beck, a brother. This deed has been lost and is not of record.

15. The above conveyances including the lost deed from Allen Beck to his brother, John T. Beck, would place the interest in the lands devised by H. J. Beck and the children of his second wife as follows:

S/6 interest in John T. Beck  
S/6 interest in H. Kinsey Beck  
S/6 interest in Etta Maney and husband L.A.W. Maney

The latter having acquired the title of Rufus H. Beck as above set out. At this point in the history of the title to this tract it was apparently considered that said John T. Beck and H. Kinsey Beck, each owned a one-third interest in said lands and that the other third was vested in the heirs at law of Etta Maney and their father, L.A.W. Maney. While this situation existed, it appears that the parties undertook and did make a division of the lands devised by H. J. Beck as set out in the will above mentioned and that the tract was divided into three equal parts, which were referred to in the subsequent deeds as lots Nos. 1, 2 and 3. Lot No. 1 apparently was set off to John T. Beck and included the southern portion of the H. J. Beck lands allotted to the children of his second wife and Lot No. 2 adjoining it on the north was allotted to L.A.W. Maney and the heirs of Etta Maney, and Lot No. 3 included the northern portion of the tract and was allotted to H. Kinsey Beck. No deeds, however, were exchanged between them as tenants in common and there is no record of any partition proceeding. Subsequent, however, to this attempted division, each of them apparently had possession of his individual tract which was allotted to him and made conveyances of the tract as if fully owned by him in fee simple.

Tracts Nos. 47 and 48 cover Lot No. 1, which was attempted to be set off to John T. Beck.

16. John T. Beck by deed dated March 16, 1903, then conveyed to S. L. Beck a tract of land containing 103 acres, which covers and includes that portion of the H. J. Beck land devised to the children of his second wife and covered by Lot No. 1 of the

attempted division made between John T. Beck, L.A.W. Maney and children and H. Kimsey Beck. This deed is recorded in Swain County and is set out on page 12 of this Abstract.

17. S. L. Beck died sometime prior to September 10, 1915 and left surviving him the following widow and children as his only heirs at law, towit:

18. By deed dated September 10, 1915, J. L. Connor and wife, M. V. Connor, H. B. Beck, L. V. Sutton and wife, H. A. Sutton, M. L. Beck, A. L. Beck, C. P. Beck, M. A. Loftis and wife, B. B. Loftis conveyed to H. C. Beck the same tract of land containing 103 acres, the deed describing the interest conveyed by each as a one-ninth undivided interest. This deed was probably made upon the assumption that the widow was entitled to a child's part in the lands instead of dower for and during her natural life. The interest actually owned by each of the children of S. L. Beck being eight in all was a one-eighth undivided interest subject to their mother's dower right. This deed is recorded in Book 44, page 26 records of deeds of Swain County, but as so recorded fails to show the acknowledgment of the deed by H. J. Beck, M. L. Beck, A. L. Beck and C. P. Beck, the deed, however, having been signed by all of them. This deed, however, was re-recorded upon a further certificate made by W. M. Bradley, a Justice of the Peace, who took the acknowledgments of all the grantors and his affidavit as to the names of the above parties is set out in the Abstract, page 13.

19. J. M. Ayers and wife, Elmira Ayers, by deed dated December 23, 1909, also conveyed to H. C. Beck all of their interest, designated as a one-ninth interest in the same tract of 103 acres. Elmira Ayers was one of the heirs at law of S. L. Beck and H. C. Beck, the grantee in the foregoing deeds also held an interest in this tract as an heir at law. This deed is recorded in Swain County. Page 15 of this Abstract.

20. On January 15, 1917, Cling Beck and wife, Nannie Beck executed to S. W. Black, Trustee for W. C. Mendenhall, a deed in trust to secure an indebtedness of \$875.00, which matured October 1, 1917. This deed in trust covers the 103 acre tract embraced in Tract 47. It is recorded in Swain County, see page 16 of this Abstract.

21. On the same date towit, January 15, 1917, Cling Beck and wife, Nannie Beck, executed a deed in trust to S. W. Black, Trustee for W. C. Mendenhall to secure an indebtedness of \$750.00, which matured September 1, 1917. This deed in trust covers the same tract of land of 103 acres. It is registered in Swain Co. Page 17 of this Abstract.

22. H. C. Beck and wife, Nannie Beck, executed a further deed in trust dated April 2, 1924 to J. S. Connor, Trustee for D. F. Connor, to secure an indebtedness of \$450.00, maturing August 2, 1924. This deed in trust is registered in Swain County. Page 18 of this Abstract.

23. H. C. Beck and wife, Nannie Beck, also executed to J. S. Connor, Trustee for J. L. Connor, deed in trust dated July 14, 1924 to secure an indebtedness of \$214.00, which matured July 14, 1925. This deed in trust is registered in Swain County. Page 19 of this Abstract.

24. H. C. Beck and wife, Nannie Beck, by deed dated March 14, 1917 conveyed to Champion Fibre Company a thirty foot right of way through and over the lands owned by the S. L. Beck heirs upon which the said H. C. Beck now lives upon the west side of the Oconaluftee River. This deed is registered in Swain County. Page 20 of this Abstract.

Allen Beck is claimed to have executed a deed to John T. Beck conveying his one-sixth interest, but the deed is not recorded and is lost.

John T. Beck and H. Kimsey Beck, who each claim to own a one-third interest and L.A.W. Maney and the heirs of Etta Maney claiming the other one-third interest jointly, undertook to partition the tract and it was divided into three lots Nos. 1, 2 and 3.
