2. This tract is covered by Grant 824 to William Cathcart dated August 9, 1796.

There is no connected registered chain of title under this grant. However, W. P. Hyde and wife executed two deeds to Calloway Treadaway, one dated Feb. 21, 1918 and the other April 23, 1921, covering 49 and 49-a. Calloway Treadaway entered and took possession under these deeds and there has been continuous adverse possession since that time.

3. However, the title under 224 became vested in W. H. Thomas and we are now taking deeds from the heirs at law of W. H. Thomas, which cover this tract and will connect the chain of title. When this deed is taken The State will acquire good title both by adverse possession and registered deeds.

NOTE: Calloway Treadaway, prior to his death executed a deed to his wife, Milligan Treadaway, to whom check should be made.
