

DESCRIPTION OF THE BOUNDARY

Analysis of Title

Tract No. 70.

1. Tract No. 70 is a part of the D. C. Gass Tract No. 59 and the title is the same as the title of Tracts Nos. 58 and 59 aforesaid.

2. On April 5, 1921, D. C. Gass and wife Dora conveyed to R. W. and Nellie Jones a small parcel or lot of land fifty feet in width and which boundary constitutes the Northern portion of Tract No. 70. This deed is duly executed and is registered in Swain County.

3. On January 1, 1924, R. W. Jones and wife Nellie conveyed to Alex Jenkins and wife Rodea Jenkins all the lands conveyed by the preceding deed except a small parcel located in the North East corner thereof which was reserved by the said R. W. Jones for the "Holiness Church Lot", the Holiness Church Lot being Tract No. 69. This deed is duly executed and is registered in Swain County.

4. The remaining or Southern portion of Tract No. 70 is said to have been conveyed by D. C. Gass and wife to Alex Jenkins but, although we have searched the records diligently, we have been unable to find any deed from D. C. Gass to Alex Jenkins. The deed is said to be unrecorded and in the possession of V. E. Quiett the present owner.

5. On January 24, 1926, Alex Jenkins and wife Rodea, conveyed to W. C. Holloway two small parcels of land which together constitute the whole of Tract No. 70. This deed also omits the small portion in the northeast corner thereof reserved for the "Holiness Church Lot". Page 779 of Abstract.

6. On February 9, 1927, W. C. Holloway and wife, Bertha conveyed to V. E. Quiett and wife Lillie E. two lots or parcels of land which together constitute Tract No. 70. This deed also omits the small parcel reserved by R. W. Jones in the North East corner as the "Holiness Church Lot". This deed is duly executed and is registered in Swain County.
