Analysis of Title

Tract No. 72.

1. Tract No. 72 belonging to A. J. Mathews is a part of the 125 acre tract conveyed by H. K. Gass to Mrs. F. H. Gass on August 24, 1907. The title to which is fully shown in the Abstract of Tract No. 58 on pages 599 to 601 inclusive.
2. On April 27, 1918, Mrs. F. H. Gass, widow, conveyed to D.C. Gass a fifteen acre tract of land which includes Tract No. 72. Page 627 of Abstract.
3. Thereafter on February 8, 1921, D. C. Gass and wife Dora conveyed to A. J. Mathews a small parcel of land containing one acre by deed duly executed and registered in Swain County. This deed covers the locus in quo, that is Tract No. 72.
4. Thereafter, to-wit: on April 7, 1921, A. J. Mathews and wife conveyed the North portion of the lot conveyed to Mathews as aforesaid to H. C. Walker; and the portion not conveyed to the said H. C. Walker constitutes Tract No. 72.

LOCATION:

This tract is located on Ravens Fork, about 3/4 miles above its mouth, and adjoins the lands of other small property owners around the sawmill.

DESCRIPTION:

A small lot on which is conducted a mercantile business.

IMPROVEMENTS:

The improvements are a six-room box house with cemented basement, a store room 20 x 45 feet, not in very good repair, a mill building 12 x 20 feet. With the exception of the store building, the place is well cared for, and the buildings are good. There is a nice garden, with fruit trees and grape vines, under a good state of cultivation.

That the said grantors for certain good and valuable considerations moving them thereto, and particularly the sum of -----ELEVEN HUNDRED ----- (\$1100.00) Dollars, to them paid by the Grantee the receipt of which is hereby acknowledged, have bargained and sold, and by these presents do hereby bargain, sell and convey unto the said grantee, its successors and assigns, the following described lands in Ocona Lufly Township Swain County, State of North Carolina, particularly described as follows, viz.:
